Councillors Mrs Wheatley and Wilson declared Personal Interests in agenda item 5, Godalming Key Site, as they were members of Godalming Town Council.

Councillor Mr P J Martin declared a Personal Interest in item 5, Godalming key Site as he was the Surrey County Council Executive Member for Schools Children and Youth Services.

10. APPLICATION WA/2007/1390 – GODALMING KEY SITE (Agenda Item 5)

Members were reminded that an appeal for non-determination was lodged against a mixed-use development at the Godalming Key Site and the Joint Management Planning Committee, on 18th December 2007, resolved that, had it been able to determine the application, it would have refused the application on 10 grounds.

The Committee was advised that during the appeal, the Planning Inspectorate had accepted revised plans as part of the appeal process and instructed the Council to formally consult all neighbours, objectors and statutory consultees on the revisions. The Inspector requested that a view was obtained from the Joint Planning Committee as to whether the revised scheme overcame any of the reasons for refusal.

The Committee considered the report, comments from the planning officer, statutory consultees and members of the public and considered, of the 10 original reasons for refusal, reasons 5 and 9 had been overcome by the revised scheme. However, reasons 1,2,3 and 10 had not been overcome and reasons 4,6,7 and 9 had not been addressed as the appellant had not yet confirmed a willingness to make the contributions and requirements requested.

At 8.59pm, it was

RESOLVED That pursuant to Procedure Rule 20, and in accordance with Section 100A(4) of the Local Government Act 1972, the press and public be excluded from the meeting during consideration of the following item on the grounds that it is likely, in view of the nature of the business transacted or the nature of the proceedings, that if members of the public were present during the item there would be disclosure to them of exempt information (as defined by Section 100I of the Act) of the description specified in paragraph 3 of Part I of Schedule 12A to the Local Government Act 1972, namely:-

Information relating to the financial or business affairs of any particular person (including the authority holding that information).

The meeting resumed in open session with the press and public present at 9.11pm when the Committee continued with questions and debate on the planning application.

In accordance with the guidance for public participation at meetings, the following representations were made in respect of the application and were duly considered:

After careful consideration, the Committee RESOLVED that had the Council been able to determine the application, then permission would have been REFUSED for the following reasons:

- 1. The scale, bulk, height and built form of the proposed development adjacent to the town centre is inappropriate and would detract from and compete with the prevailing character of the locality and setting of the Conservation Area in conflict with Policies SE4 and SE5 of the Surrey Structure Plan 2004 and Policies D1, D4, TC6 and HE8 of the Waverley Borough Local Plan 2002.
- 2. The design by reason of the palette of materials, over complex variety in the detailing would fail to provide a development that is locally distinctive and would be inappropriate to the site contrary to Policy SE4 of the Surrey Structure Plan 2004, Policies D1 and D4 of the Waverley Borough Local Plan 2002 and the principles of Surrey Design 2002.
- The proposed development would be detrimental to the amenity of neighbouring properties by reason of its overbearing impact in conflict with Policy SE4 of the Surrey Structure Plan 2004 and Policies D1, D4 and TC6 of the Waverley Borough Local Plan 2002.

- 4. It has not been satisfactorily demonstrated that the transportation implications of the proposed development can be adequately accommodated by the transportation infrastructure within the area contrary to Policy DN2 of the Surrey Structure Plan December 2004, and Policy M2 of the Waverley Borough Local Plan 2002.
- 5. The development does not make provision for affordable housing in accordance with Government Guidance and Policy DN11 of the Surrey Structure Plan 2004 and Policies H5 and D14 of the Waverley Borough Local Plan 2002.
- 6. The development does not make adequate provision for equipped play space and indoor sports in conflict with Policies DN1 and DN13 of the Surrey Structure Plan 2004 and Policies H10 and D14 of the Waverley Borough Local Plan 2002.
- 7. The development does not make provision for a contribution to Education provision in the area in conflict with Policy DN1 of the Surrey Structure Plan 2004 and Policy D14 of the Waverley Borough Local Plan 2002.
- 8. In the absence of information to clarify the improvements required to the drainage infrastructure the Council is concerned that a Grampian Condition may be inappropriate as there is uncertainty about the prospects of such improvements being achieved to make the development acceptable and therefore conflicts with Policy DN1 of the Surrey Structure Plan 2004 and Policy D13 of the Waverley Borough Local Plan 2002.
