31. MAYOR'S ANNOUNCEMENTS

The Mayor reminded Members that at the last meeting in July the Council took the decision to advertise for a new Strategic Director for a fixed-term of 12-18 months. The Mayor was pleased to inform Members that the Restructuring and Human Resources Special Interest Group had met the previous day to undertake the interview and selection process, and had decided to offer the position to Jonathan Poore, who is currently a management consultant with Turner & Townsend in London. Jonathan was delighted to accept the offer and was expected to take up that position early in the New Year.

The Mayor informed the Council of a number of enjoyable events that she had attended which included the presentation of prestigious awards to the Frensham Pond Sailing Club and the Mayor's charity, the Woodlarks Campsite Trust. The Mayor had also attended a very special art exhibition by the young people of Waverley Training Services and undertaken an enjoyable and informative twinning visit to Mayen-Koblenz.

The Mayor then provided councillors with some dates for their diaries:-

"Mr Hyman I too thank you for your question. I consider it insulting to the Mayor, our First Citizen, to suggest she owes an apology for undertaking the Mayor's absolute responsibility for ensuring that Council business is carried out efficiently. 33. PRESENTATION OF PETITION

The Mayor received a petition, presented by the 1st Witley Scout Group, on behalf of 205 signatories, the prayer of which was as follows:-

"Bearing in mind that the dirt jumps that were built in the woods near Oxted Green have been removed and that there are no facilities for skate boarders, can the Council consider the erection of some jumps and a skate park in one of the recreation parks in the Milford/Witley area."

The Mayor gave the following response:

"The Council is committed through its Corporate Plan to give opportunities for all to take part in sport, recreation and culture, with leisure being identified as one of its top five priorities for 2008/2011. In accordance with this priority the Council already provides five skate parks across the borough, and has also

constructed six hard-court areas over recent years. We will certainly be willing to provide technical support and assistance with fund raising to the 1st Witley Scouts to help them with this project should they require it. However, unfortunately we would be unable to provide any land for such a facility in the Milford/Witley area because we do not own or manage any sites of sufficient size in either village. I would therefore suggest that having obtained over 200 signatures in support of this initiative, the Scouts would be best advised to approach the local Parish Council for help in identifying possible sites as they are responsible for the maintenance of the majority of open spaces in the area. Should a suitable location be identified, rest assured that we will then do everything we can to work with those concerned to progress the project further. I am delighted to see you here today and taking an interest in local democracy and if any of you would like to become involved with our Top Youth Council which is made up of young people aged 12-18 please get in touch with Robin Pellow at Waverley. Thank you all very much for coming."
