152. <u>EXECUTIVE FORWARD PROGRAMME</u> (Agenda Item 6)

RESOLVED that the forward programme of key decisions for Waverley Borough Council be adopted.

153. BUDGET MONITORING NOVEMBER 2009 (Agenda Item 7; Appendix B)

RESOLVED that

1. the position as at 30 November 2009 be noted;

- 2. £6,000 of the Car Park Capital Programme savings and £8,000 of the Air Quality Improvement Works be reinstated;
- 3. the following capital schemes totalling £50,000 be undertaken during 2009/10 from the savings identified within the Capital Programme:
 - BMS Front Panel, Cranleigh Leisure Centre £15,000
 - 2nd Low-Carbon Pool Car £7,000
 - Telephone upgrade to customise call handling £19,000
 - Link to Farnham Sports Centre for elections £9,000; and
- 4. the Budget to continue to be closely monitored during the remainder of 2009/10.

- 2. the Executive give final consideration to the HRA budget for 2010/2011 at the meeting on 2 February 2010.

- 4. the Sustainability Co-ordinator be thanked for the excellent work in progressing this strategy.

156. <u>DISPOSAL OF HOUSING REVENUE ACCOUNT PROPERTY</u> (Agenda Item 10; Appendix E)

RESOLVED that

- 112 Ockford Ridge, Godalming, be disposed of on the open market on terms to be negotiated by the Council's Deputy Chief Executive and the Estates and Valuation Manager; and
- 2. the capital receipt from the sale of this property be applied to contribute towards achieving the Decent Homes Standard in the remaining Council housing stock.
- 157. <u>FUTURE USE OF HOUSING REVENUE ACCOUNT PROPERTY IN FARNHAM</u> (Agenda Item 11, Appendix F)

RESOLVED that

- 1. the disposal of Marshall's, Weydon Lane, Farnham, to Mount Green Housing Association be approved on the revised terms from the original agreement in January 2009 negotiated by the Council's Estates and Valuation Manager, which include that the building is to be used as a mixed scheme of affordable housing to which the Council will receive nomination rights and as set out in the Exempt Annexe; and
- 2. the capital receipt from the sale of this property be applied to contribute toward achieving the Decent Homes Standard in the remaining Council housing stock.
- 158. <u>GODALMING CENTRE MANAGER/PROJECT CO-ORDINATOR</u> (Agenda Item 12; Appendix G)

RESOLVED that

- 1. the creation of a Godalming Town Manager/Project Co-ordinator post be supported;
- 2. funding of £10,000 per annum for two years be provided matching the contribution made by Godalming Town Council; and

3. the post be hosted by Waverley Borough Council.
