# 10. WA/2010/0372 VARIATION OF CONDITION 37 OF PLANNING PERMISSION WA/2008/0279 AT LAND AT EAST STREET, FARNHAM

The Council is of the opinion that Condition 37 of WA/2008/0279 should not be varied as the consequences of not complying with criterion (a) of the condition would be likely to cause material harm by way of loss of air quality, excessive traffic congestion and related inconvenience to highway users, visitors and businesses and material loss of amenity to local residents contrary to Policy NRM9 of the South East Plan 2009 and Policies D1, TC12, TC13 and M2 of the Waverley Borough Local Plan 2002.
