85. MINUTES (Agenda Item 2)

The Minutes of the Meeting of the Executive held on 5 October 2010 were confirmed and signed.

86. <u>DISCLOSURE OF INTERESTS</u> (Agenda Item 4)

There were no interests raised under this heading.

87. QUESTIONS (Agenda Item 5)

The Executive received the following question from Mrs Sandars of Farnham in accordance with Procedure Rule 10:-

"The Chancellor's Spending Statement to Parliament on 20 October set out radical changes affecting social housing. We know that Housing Benefit and other benefits are to be capped and that Local Authority budgets are to be cut by almost 28% over the next four years and we were told yesterday that the Capital Budget for housing would be slashed and rents increased to 80% of market rates. A spokesman for the National Housing Federation said after that statement that 'the outcome will be more people sleeping on floors'.

"Please would the Chairman tell me, firstly, how Waverley's ability to provide homes for those on the Council's waiting list will be affected by government measures – does he expect more on less names to be added to that list; does he expect more or less affordable home to be provided by the Council and, secondly, what new initiatives will the Council be looking for to mitigate the dreadful problems for those of our fellow citizens in Waverley who so need social/affordable housing?"

The Leader responded initially, followed by the response by the Portfolio Holder for Housing, as follows:-

"I'm grateful for the opportunity to put some of the problems that our tenants in this Council have suffered during the 13 years of labour misrule. Many of the dreadful problems you refer to in the question are a direct result of Labour chancellor Gordon Brown who, even in the good years, ran a budget which in every year was in deficit. You will be aware that the Labour Government took half of our tenants' rents and sent that money to other parts of the country, often into labour marginal seats. This was deliberately taking money from the least well off in our borough. To a large extent, the position that both the country and this borough finds itself in is due to that labour government. In terms of the debt to GDP, Malta, Austria, Canada, Singapore, Estonia, Lithuania and many others rank in a better position than the terrible situation we found ourselves in May. However, as always, this administration have been talking to ministers, lobbying on behalf of our tenants and Cllr Webster will give you news of our plans for the future."

"Thank you for your question. We in this Council understand that the primary concern of the Coalition Government must be to rectify the parlous state of the national finances which it inherited and we regret that some sacrifices might be required to achieve this. 'The Coalition Government is quite right to be concerned about the spiralling cost of housing benefits, particularly in some urban areas. We support their efforts to reduce the unsustainable national debt and to change our social culture from one of extreme dependency.

The Government recognises the importance of a balanced supply of housing – private, affordable and intermediate, as do we. Affordable housing is one of this Council's top priorities and one of its toughest, and in this period of uncertainty, we are working successfully with our partners to deliver new housing developments.

We have recently been successful in securing government funding for the development at the Rowland House site in Cranleigh and the Marshalls site in Farnham, and we are developing an excellent proposal for the housing at Station Road in Godalming. The Council has also formed its new wholly-owned company – Waverley Initiatives Ltd – with the purpose of developing new housing on land owned by the Borough.

As Portfolio Holder for Housing, I am proud to take this opportunity of mentioning the excellent achievements of our housing service for our tenants, despite sending more than half of our tenants' rents to the Treasury. We have top performance in reducing our re-let times, the high level of insulation in our properties, 97% satisfaction with repairs, 99.98% gas safety checks successfully carried out, our successful crackdown on antisocial behaviour etc etc, plus a choice-based letting service for those on the housing register and a range of new housing in our towns and villages for local people in housing need. But as the King said to the Prime Minister during the War, 'KBO' - 'Keep Battling On' - we must and we will."

The need for an HGV/Freight Strategy

- Hot spots of congestion in the borough at peak times, including Hickleys Corner, the A3, Milford Roundabout and Petworth Road in Witley
- Air quality issues
- Deterioration of train service and the lack of ongoing public transport such as buses
- Importance of maintaining the road network
- Impact of major developments inside the borough and cross-boundary.
- RESOLVED that the response to the Local Transport Plan consultation be agreed, setting out the most important transport issues that impacted on Waverley's communities and that the Leader be given delegated authority to approve the response, including the range of points on both general and specific local issues raised by members and listed above.
- 94. REVIEW OF THE LOCAL INFORMATION REQUIRMENTS FOR THE VALIDATION OF PLANNING AND OTHER APPLICATIONS (Agenda Item 12; Appendix G)
