"During his 13th January visit to speak with government minister, Bob Neill, to press for a "fairer deal" for Waverley's residents, the Leader delivered a written submission that contained claims that could be considered to be misleading to the minister. One in particular said that, "Since 2008, Waverley has reduced the number of Directors from 6 to 2...", a claim that was reiterated in part by Councillor Steel, at a meeting of the Executive on the 25th January.

I expect that Members present who were councillors during the last administration will recall that reports brought to Council on 'Senior Management Restructuring', in 2006, referred to the Liberal Democrats intention to seek to reduce the number of Directors from five to four and then to three. Imagine then my surprise to read that by 2008, under this Conservative Administration, the number of Directors had increased to six and my further confusion in learning that there are now only two.

As part of the Restructuring review in 2006, members of the Liberal Democrat Executive and opposition leaders visited a number of other local authorities to investigate different Senior Management Structures; at no point was there any confusion on the definition of a Director. It would seem, however, that there now is some doubt as to what criteria we should use to define a Director at Waverley. It is clear to me that the criteria used by this Conservative Administration must be different

from that used by other authorities and the last Liberal Democrat Administration. It is also possible that this Conservative Administration has changed its criteria again between 2008 and 2011.

To clear up this confusion, would the Leader like to explain the criteria used to define a director, the names of the six Directors in 2008 and the current two?"
