#### 62. DISCLOSURE OF INTERESTS

Cllr Julia Potts declared a personal interest as a Farnham Town Councillor and small shareholder in Marks and Spencers. Cllr Jenny Else declared a personal interest because her nephew was an employee of Crest Nicholson.

Cllrs Paddy Blagden, Carole Cockburn, Jill Hargreaves Stephen Hill, Roger Steel and John Ward declared personal interests as members of Farnham Town Council. Cllr Pat Frost declared a personal interest as a Farnham Town and Surrey County Councillor.

Cllr Janet Somerville also declared a personal interest as a small shareholder of Marks and Spencers.

### 63. MINUTES OF THE SPECIAL EXECUTIVE – 24 APRIL 2012

It was moved by the Chairman of the Executive and duly seconded that the Minutes of the Special Meeting of the Executive held on 24 April 2012 be approved and adopted.

The Mayor explained that all members had received advice from the Borough Solicitor in an email about an issue of personal liability for members raised by a member of the public and explaining that members were not personally liable, as alleged.

The Borough Solicitor gave a detailed introduction to each of the three reports for consideration at the meeting. With regard to the report relating to the Appropriation of Land at Brightwells and Riverside, the Section 151 Officer reminded councillors about the requirement under Section 123 of the Local Government Act 1972 for Councils to achieve best consideration when disposing of an interest in land. He went on to clarify that this meant not simply to achieve the best market value but also the ability for Councils to take into account reasonable social and regeneration objectives and benefits to help determine what is best consideration. Having received appropriate legal, property and financial advice, the Section 151 Officer informed the Council that he was of the view that Brightwells fulfils these requirements, and not only would it secure a capital premium in the form of the Minimum Land Value, plus a share of commercial rents, it would also achieve regeneration of a run-down part of Farnham to include a multi-screen Cinema, a new day centre, shops and restaurants plus 72 affordable homes, as well as 28.4% of additional open space.

RESOLVED that the Minutes of the Special Meeting of the Executive held on 24 April 2012 be approved and the recommendations contained therein adopted, as follows:-

#### A. Brightwells – Rectification of Deed of Covenant

Recommendation 58 be approved and adopted.
