Consultation Statement September 2012

Introduction

When preparing documents that will be adopted as a material consideration when determining planning applications, it is deemed best practice to undertake a robust consultation, seeking the views of local residents and key stakeholders.

To support this Consultation Statement be prepared setting out who was consulted in connection with the preparation of the draft document, how they were consulted, a summary of the main issues raised in those consultations and how those issues have been addressed in the document.

The draft Farnham Conservation Area Management Plan (FCAMP) was approved for consultation by Waverley Borough Council's Executive Committee on 27 March 2012.

The draft document has evolved from the adopted Farnham Conservation Area Appraisal (2005) and more recent guidance supporting the need to undertake Conservation Area Management Plans (produced by English Heritage)

The proposed FCAMP document aims to set a clear programme for future environmental enhancements, and sets out what is needed to be done to ensure that the conservation area is both preserved and enhanced.

Consultation Process

The draft FCAMP document was subject to a consultation between Tuesday 8 May 2012 and Monday 9 July 2012.

The document was available to view in the following locations:

- to read or download from the Council's website (via www.waverley.gov.uk/fcamp),
- to view at Planning Reception, Godalming,
- · to view at Farnham Town Council, and
- upon request from Planning Policy.

A variety of key stakeholders were invited to participate and each was contacted by letter. These stakeholders included:

In addition over 760 local residential properties were sent a letter inviting them to participate and every business within the conservation area had a leaflet explaining the consultation hand delivered.

Whilst the notification was focused, this did not prevent any other interested parties from getting involved with the consultation.

Respondents were able to comment on the draft document in a variety of ways, including:

- using the online survey (SurveyMonkey), which was linked to from the main web page (this did not require registration),
- · by email directly to Sarah Wells, or
- by letter.

Two key questions were asked of respondents:

- 1. Do you have any comments on the draft Farnham Conservation Area Management Plan?
- 2. Should the draft Farnham Conservation Area Management Plan include any other environmental or public realm improvements or cover any other issues?

Respondents were also given the opportunity to give any additional comments that they thought were relevant to the draft document.

Consultation Response

29 responses were received to the consultation from key stakeholders, local organisations and local residents. The main issues raised by the consultation are outlined below:

- Public Art
- Traffic
- Shared Space
- Adverts
- Planning Policy
- Trees & Open Space

- Environmental Enhancements
- Retail (general comments)
- Funding
- Designations
- Celebration
- General Matters

Many of the issues raised are not within the remit of the FCAMP group; however they will be forwarded to the relevant Officers, Services or organisations. Those matters which are relevant have, where appropriate, been addressed in the document.

Following the consultation and having given consideration to all the consultation responses, the draft Farnham Conservation Area Management Plan has be reviewed, amended and updated before being presented to Full Council in October 2012 for formal adoption.
