Consultation for Godalming Conservation Area Appraisal (CAA)

Introduction

Waverley Borough Council prepared a draft Conservation Area Appraisal (CAA) for Godalming Town Centre and carried out an associated consultation. This report outlines how the consultation was undertaken, who was involved and how responses were considered.

Consultation Process

The consultation started on Thursday 11 July 2013 for six weeks, ending on Thursday 22 August 2013.

The following methods to inform the public of the consultation included:

- A letter to all residents in the CA
- A leaflet to all businesses in the CA (hand delivered)
- A letter for key stakeholders including:
 - Town Council
 - Surrey County Council
 - Statutory consultees (English Heritage, Natural England and Environment Agency)
 - Amenity Society (the Godalming Trust)
 - Relevant internal Waverley officers
 - Local Councillors

An email was also sent to members of the Steering Group.

A presentation was given to the Chamber of Commerce on 16th July 2013 and the Godalming Business Network was also informed. It placed details of the consultation on Linkedin.

A poster and hard copy of the draft Godalming Town Centre CAA document was made available at Planning Reception, Council Offices, Godalming (Monday to Thursday 9am – 5pm and Friday 9am – 4pm) and a copy could be viewed online at:

282 individuals and organisations were contacted by letter (see Appendix A for full list of those consulted). Whilst the consultation was focussed, it did not preclude other interested parties from responding. In addition to the webpage on the Council website, a press release (Appendix B) was issued to inform the public of the consultation.

A full summary of the consultation responses and the Council's response is attached at Appendix C. The main issues have been identified as a result of this process and where practicable and appropriate, amendments made to the CAA.

A Steering Group consisting of members from Godalming Town Council, the local amenity group, local Councillors, Surrey County Council and the Chamber of Commerce was set up. This group was active in the preparation of the CAA and met regularly to discuss various drafts of the document. In addition a walkabout was conducted and environmental enhancement projects for the management plan were highlighted. This gave participants the opportunity to raise questions, but also to gain feedback on the content.

Respondents were able to comment of the draft Godalming Town Centre CAA online, by email or by letter. Respondents were asked to consider two key questions:-

- 1. Do you have any comments on the draft Godalming Town Centre Conservation Area Appraisal?
- 2. Should the draft Godalming Town Centre Conservation Area Appraisal cover any other issues?

Respondents were also given the opportunity to give any additional comments that they thought were relevant to the draft CAA.

Consultation Responses

26 responses were received to the draft document. The main areas raised related to the Management Plan and as a result it has been updated to include additional issues such as litter and fly posting. Recommendations for environmental enhancement to Wiggins Yard, the public realm outside the Red Lion and Station Road were also supported.

A potential new CA just outside Godalming Town Centre on Westbrooke Road will also be examined as a separate piece of work.

Next Steps

The consultation has informed the necessary amendments to the document before submitting through the committee process (Executive and Full Council) for adoption as a material consideration in planning applications and to inform future environmental enhancement works.

Call For Community To Have Its Say On Godalming's Conservation Area

Waverley is seeking views on the draft conversation area appraisal of Godalming Town Centre.

The town centre is one of 43 conservation areas in the borough and Waverley is keen that it keeps pace with any changes. To do that, views from across the community are needed.

As part of the appraisal on which people can comment, Waverley is considering some improvements that would need to be in keeping with the conservation area. Areas already identified for consideration include:

- Angel Court
- Station Road/Station Approach
- Moss Lane
- Crown Court
- Wiggins Yard
- The Friday Market

The draft Godalming Town Centre Conservation Area Appraisal is open for comment until August 22 and is made up of two parts – one identifies and explains its special character while the other sets out the long term management plan for the area.

Cllr Bryn Morgan, councillor responsible for planning at Waverley Borough Council, said: "Godalming Town Centre is a unique part of Waverley and we are keen that it is maintained and improved in the right way. This needs community input and the Conservation Consultation Appraisal allows people to make comments on what has been put forward but also suggest other issues they feel should be covered.

"It is important that the conservation area is looked at from time to time and the last time Godalming Town Centre was considered was almost 25 years ago. Many things have changed since then and it is important that the heritage is protected and the town centre continues to thrive."

The uneven surfaces are a risk to all pedestrians, and more so to those with any mobility issues. It is difficult enough during dry weather, but the problems are compounded during rainy times as we have to negotiate large puddles as well. Three of our residents are especially affected by this, and two of them have asked me to support them in writing to you (they have a learning disability) about their difficulties and views about the cobbles. I shall be sending separate letters from each of them in due course. Another resident is currently in hospital, but I can tell you that the disrepair of the cobbles has contributed to her being nervous of going out to the shops as she is quite frail and could easily fall. She needs someone with her to ensure that she is safe, but this is not always possible. The consultation has a few ideas. It highlights the wall between the truncated Mill Lane and Station Road/Borough Road, that's been left orphaned after the ring road was created and the High Street made one way. Working in Mill Lane, I regularly get asked by visitors who have reached this spot – "Which way is the High Street?". Its not obvious the route across, and nor can you see the High Street from this spot. So I would say there is a wall, railings and some trees to be removed. Having run the gauntlet of many speeding College students, there does need to be some sort of traffic calming to help with the crossing. Exiting Mill Lane by car or bike is a blind junction, and needs to be done both slowly (when approaching the junction so as not to meet an oncoming car turning down Mill Lane, and then at speed to not be hit by a car whizzing round the corner from Station Approach. Luckily when most commuters are trying to cross (between 5-7pm) the traffic is generally backed up to the traffic lights, which provides a natural traffic calming. But at other times, its a case of looking, running and crossing fingers. The Red Lion space is underused, and the wall really divides the High Street from linking to the station. Now that the parking free for all has been resolved, this could be a really interesting event space for the town. I'm not sure we are served well by the iron bollards – if they are not uprooted leaving horribly tarmaced potholes, they just seem to get in the way. Some people hold Godalming's street ironwork in high regard. Given it came out of a catalogue in the first place, perhaps we could choose some new ones? So (below) here's a really underused space outside Mistral – an iron fence, bin, 2 bike stands and a bell shaped bollard. What a lot of clutter for very little functionality.
