5. <u>TECHNICAL BRIEFING RE APPLICATIONS RELATING TO LAND AT EAST</u> <u>STREET, FARNHAM</u>

The purpose of this meeting is to assist Members in clarifying any matters in planning applications WA/2008/0279 and WA/2008/0280 about which they are unclear or require further information. At this technical briefing there will be extended public speaking facilities.

The briefing report on the main application has already been circulated as <u>Appendix A</u>, and the report on the Listed Building application is attached as <u>Appendix B</u>.

Members will be asked to consider, debate and determine the applications at the meeting of the Joint Planning Committee on Wednesday 11th June 2008. The order of business on 11th June will be to consider the main East Street application first, followed by the application for Listed Building consent. There will be separate opportunities for public speaking in respect of each of the applications at that meeting.

The main application includes a planning application for extensions to and change of use of the Listed Building. The key considerations in this respect are whether the proposed extensions and use are appropriate in planning terms. The main application is also concerned with the loss of the theatre facility. This is **not** a matter for the Listed Building application.

The Listed Building application is for the physical works to the building only, and the matter of the change of use is not a material consideration. Whilst the application includes the demolition of the Redgrave Theatre the determination tests in the Listed Building application are whether the building to be demolished has any special architectural or historic interest and if it does whether there is a justification in Listed Building terms. It is quite possible in applying the appropriate tests that Members may find one application acceptable and not the other.
