#### ELEMENTS OF OPERATING SCHEDULE TO ADDRESS LICENSING OBJECTIVES:

#### a) General - all four licensing objectives (b,c,d,e)

Staff shall be trained on the requirements of the Licensing Act 2003 when they are recruited and shall be given training in 'drugs awareness' as part of their induction.

#### b) The prevention of crime and disorder

There shall be access to the pub's toilet facilities and provision of non-alcoholic refreshment during the wind down period.

A personal licence holder shall be present on the premises whenever there is trading after 2230. The Designated Premises Supervisor shall be a member of the Farnham Pubwatch scheme, so long as it exists.

#### c) Public Safety

The licensee and staff shall have regard to any risk identified in the risk assessment.

#### d) The prevention of public nuisance

Live music shall end at 2330 except on New Year's Eve and New Year's Day.

Recorded music indoors shall end at 0000 on Sundays - Thursday and at 0100 on Friday and Saturday except on New Year's Eve and New Year's Day.

Recorded music volume shall be replaced during a wind down period during the above hours to background level to create a mood change.

All windows shall be kept closed.

The garden shall be closed at or before 2300.

Notices shall be displayed prominently at the exits asking customers to leave the premises quietly. The kitchen extract filters shall be cleaned regularly to minimise the impact of cooking smells on neighbours.

#### e) The protection of children from harm

The licensees and staff shall have regard to the restrictions set out in the Licensing Act 2003. Photographic proof of age shall be required to be shown by anyone seeking to purchase alcohol who appears to be under 20 years of age.

#### Conditions agreed with the Environmental Health Officer:

- The licensee shall install a lobby to the main entrance, so as to provide two sets of doors separating the bar area from the outside of the premises. All doors shall be fitted with self-closers and maintained in good working order. The distance between the inner and outer doors shall be sufficient to ensure that one door set is normally closed as people pass through the lobby.
- External doors and windows serving the licensed area shall be kept shut at all times. Doors
  may be opened for normal entrance and egress of people but must be shut immediately
  thereafter and must be fitted with self-closers, which shall be maintained in good working
  order.
- 3. The outside seating area shall not be used for any purposes between 2300 hours and 0800 hours.
- 4. The licensee shall display notices at all public exits requesting customers to take all steps to minimise noise once they have left the premises. The wording and size of such notices shall be agreed in writing with the Environmental Health Section at Waverley Borough Council.

We feel that the Premises Licence Holders and Designated Premises Supervisor are failing to exercise proper management and control over the day to day running of the premise and that they are failing to promote the Licensing Objectives contained in the Licensing Act 2003

We therefore recommend that CCTV be installed at the premises to assist with the management of the inside and outside of the premises

We recommend that all staff be re trained by an outside company and that the following conditions be added to the licence.

With effect from 21st December 2009 the licence holder shall maintain a comprehensive digital colour CCTV system at the premises that ensures all public areas of the licensed premises are monitored, including all public entry and exit points, car park and garden. The system will enable frontal identification of every person entering in any light condition. All cameras shall continually record whilst the premises are open to the public and video recordings shall be available for a minimum of 31 days with time and date stamping. Recordings shall be made available to an authorised officer or police officer together with facilities for viewing. The recordings for the preceding two days shall be made available immediately on request. Recordings outside this period shall be made available on 24 hours notice (Subject to the requirements of the Data Protection Act 1998).

There shall be a personal licence holder on duty at the premises at all times when alcohol is being sold.

Staff shall be trained in the basic law relating to the sale/supply of alcohol and written records will be kept for inspection. This will include the law relating to both the sale and the consumption of alcohol to persons under18 and the refusal of sale of alcohol to persons who are drunk. There will be an ongoing training regime.

The premises will operate a Challenge 21 policy and will only accept passport, photo driving licence or ID cards bearing the PASS hologram as forms of identification.

A log shall be kept detailing all refused sales of alcohol. The log should include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be available for inspection at the premises by police or an authorised officer of the Borough Council or Trading Standards.

An incident log shall be kept at the premises and made available on request to an authorised officer of the Borough Council or Police, which will record the following;

- a. All crimes reported to the venue
- b. all ejections of patrons
- c. any complaints received
- d. any incidents of disorder
- e. seizure of drugs or offensive weapons
- f. any faults in the CCTV system
- g. any visit by a relevant authority or emergency service

All staff will be trained in drug awareness and written records will be kept for inspection. Staff will carry out regular checks of the toilets and these checks will be documented and will be available for inspection.

When the premises is booked for a private event then written records will be kept of the name, address and contact details of the person making the booking. These records will be made available to police on request.

Surrey Police assert that the Premises Licence Holders and Designated Premises Supervisor are failing to exercise proper management and control over the day to day running of the premise and that they are failing to promote the Licensing objectives.

In order to address these issues we recommend that CCTV be installed at the premises to assist with the management of the inside and outside of the premises and that all staff be re trained by an outside company. In order to implement these recommendations Surrey Police suggest the following conditions be placed onto the Premises Licence

With effect from 21st December 2009 the licence holder shall maintain a comprehensive digital colour CCTV system at the premises that ensures all public areas of the licensed premises are monitored, including all public entry and exit points, car park and garden. The system will enable frontal identification of every person entering in any light condition. All cameras shall continually record whilst the premises are open to the public and video recordings shall be available for a minimum of 31 days with time and date stamping. Recordings shall be made available to an authorised officer or police officer together with facilities for viewing. The recordings for the preceding two days

shall be made available immediately on request. Recordings outside this period shall be made available on 24 hours notice (Subject to the requirements of the Data Protection Act 1998).

There shall be a personal licence holder on duty at the premises at all times when alcohol is being sold.

Staff shall be trained in the basic law relating to the sale/supply of alcohol and written records will be kept for inspection. This will include the law relating to both the sale and the consumption of alcohol to persons under 18 and the refusal of sale of alcohol to persons who are drunk. There will be an ongoing training regime. A record of training shall be available for inspection at the premises by police or an authorised officer of the Borough Council or Trading Standards.

The premises will operate a Challenge 21 policy and will only accept passport, photo driving licence or ID cards bearing the PASS hologram as forms of identification.

A log shall be kept detailing all refused sales of alcohol. The log should include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be available for inspection at the premises by Police or an authorised officer of the Borough Council or Trading Standards.

An incident log shall be kept at the premises and made available on request to an authorised officer of the Borough Council or Police, which will record the following:

- a. All crimes reported to the venue
- b. all ejections of patrons
- c. any complaints received
- d. any incidents of disorder
- e. seizure of drugs or offensive weapons
- f. any faults in the CCTV system
- g. any visit by a relevant authority or emergency service

All staff will be trained in drug awareness and written records will be kept for inspection by a member of the Borough Council or Police Licensing Officer. Staff will carry out regular checks of the toilets and these checks will be documented and will be available for inspection.

When the premises is booked for a private event then written records will be kept of the name, address and contact details of the person making the booking. These records will be available for inspection at the premises by Police or an authorised officer of the Borough Council or Trading Standards.

No licensable activities shall take place in the garden or outside areas after 19:00 including any Temporary Event Notices.

Application for the review of premises licence under the Licensing Act 2003

1. Identified Environmental Health issues relevant to the four licensing objectives

Prevention of public nuisance.

#### 2. Conclusion

I write in response to the application for review of the Premises Licence of The Royal Arms, 172 Farnborough Road, Farnham submitted by Surrey Police.

The Environmental Health Department of Waverley Borough Council would like to make the following representation in support of the application.

This relates to the licensing objective of the prevention of public nuisance.

The Royal Arms Public House is situated off the Farnborough Road in a predominantly residential area, although another business, Hexagon mobility centre is situated on the north side of the premises on the main road. This however is closed outside normal office hours. There is also a petrol station to the south of the premises.

Mr Jon- Paul Stubbings and Ms Toni Greenway became the premises licence holders and Mr Stubbings the designated premises supervisor (DPS) on 24th November 2005. Since that date, The Royal Arms has frequently come to the attention of Environmental Health Officers with regard to complaints in relation to public nuisance.

Complaints began in July 2006 and have been received either directly to the main council office or to the out of hours service, when complaints have been made of noise preventing sleep. Several letters, telephone calls and site visits have been made to the premises to advise Mr Stubbings and Ms Greenway of the various complaints and many investigations have been carried out.

The following is a brief description of the complaint information recorded by Environmental Health which relates to this review.

28<sup>th</sup> July 2006- three complaints of loud music from a disco being held in the garden. An officer visited with the police to advise of the complaint and make suggestions to minimise disturbance to local residents.

12<sup>th</sup> August 2006- two complaints of music over a prolonged period of time due to a festival being held at the premises, which involved outside bands and recorded music from approximately 4.30pm to 10.45pm. Also mention of offensive language over PA system. Initial complaints received by out of hours officers, who were told by a member of staff that the music was at 110dB and this was allowed. Officer advised that music needs to be turned down or off. Letters were sent and contact made with Police over their involvement. In addition a visit by Licensing Officers to notify the licence holders that music is not allowed within the garden.

26<sup>th</sup> August 2006- complaint of loud music to out of hours service, alleged to be due to the windows being open. Officer called pub and spoke with Ms Greenway. She advised 50<sup>th</sup> anniversary party and three windows were open as a lot of people and very hot. Officer advised her to close them. Call received by complainant that music ceased at midnight. Letter sent to pub advising of complaint.

- 1<sup>st</sup> September 2006- noise complaint was received due to very loud music being heard and anti-social behaviour on two occasions.
- 4<sup>th</sup> September 2006- noise complaint regarding people screaming and shouting whilst using one of the bouncy castles until 11pm on Sunday 3rd. Site visits and letters were sent regarding issues from Environmental Health and Licensing.

2<sup>nd</sup> June 2007- noise complaint was received by the out of hours service due to loud music from premises, this was felt to be due to a breach of licensing conditions, as windows were open. Also on-going problems from noise generated from the bouncy castles on site.

19<sup>th</sup> June 2007- noise from generators supplying the bouncy castles. A conversation was had with the DPS who advised four are on generators, with the rest on mains. He advised consideration was being given to housing the generators to prevent noise, stopping at 6pm and possibly another means of powering the bouncy castles. Case closed after bouncy castles appeared to be out of use for the next month.

8<sup>th</sup> September 2008- complaint of burning of plastics every Monday morning. A letter was sent to the pub on 15<sup>th</sup> September, however complaints continued. A site visit was carried out on 14<sup>th</sup> October when burning was witnessed. Ms Greenway admitted to burning in an old wheelie bin three times a week.

12<sup>th</sup> October 2008- complaint of loud music and people on the street to out of hours service. Advised Police had been notified also. Complainant reported thumping music after 2am and windows being open. Spoke to Ms Greenway about complaint, she informed me there had been an incident on the Friday night involving the Police and they visited on Saturday but not aware of any issues on the Saturday night.

24<sup>th</sup> & 25<sup>th</sup> March 2009- two complaints of bonfires every day for previous week and burying waste from external contractors in the garden. Officer visited site and saw evidence of recent bonfires. Reported to the Environment Agency.

24<sup>th</sup> March 2009- in addition a complaint of noise from the bouncy castle generators and screaming from people using them.

20<sup>th</sup> April 2009- noise complaint due to loud music from two previous Saturday nights, music reported to be past 1am and windows open. Letter to DPS was sent on 24<sup>th</sup> April and the complaints received by Environmental Health were raised with the Town Centre Disorder Group in the following meeting.

28<sup>th</sup> April 2009- two complaints of rubbish in the street, which I was advised had been there for a couple of weeks. Reports of black bags which were getting torn up by animals, a chest freezer left on the pavement and bins overflowing. Spoke to Ms Greenway about issues.

16<sup>th</sup> August 2009- two complaints of loud music. Music was originating from back garden. Information from Licensing Department indicated that a temporary event notice had been granted for this date to Mr Stubbings. Complaints were not pursued as felt to be one off.

29<sup>th</sup> August 2009- noise complaint of loud music due to outdoor event received by out of hours officers, music heard over the phone by officer. Officers rang DPS and notified of disturbance, agreed music to be turned down. Service was called again later in evening by the complainant to advise no change in levels and PA system can be clearly heard. Out of hours team attended but music had ceased, however generator noise and loud voices were witnessed. DPS was rang again and asked to turn the generators off. DPS advised he was not aware of situation and turned the generators off. This again was due to a temporary event notice being granted to Mr Stubbings for use of the premises on this date.

28<sup>th</sup> October 2009- concerns of toxic materials on a bonfire being prepared in garden and land being used as a landfill site. Environment Agency were notified and visited. They reported back that there were concerns of various materials being intended to be burnt, however DPS advised materials had been fly tipped.

#### In Summary:

Since July 2006 there have been 17 occasions that have been reported to Environmental Health as causing local residents distress, disturbance or concern regarding this premises and 13 separate complainants.

Environmental Health have contacted The Royal Arms multiple times by way of letters, telephone calls and site visits with regard to various issues including noise, bonfires and accumulations of rubbish.

The Premised Licence Holders and Designated Premises Supervisor have failed to adequately manage the premises on a number of occasions. The occasions that have caused most disturbance are events under temporary event notices with external music or when it is alleged that licensing conditions are being breached in respect of doors and windows being left open. Due to the restriction of no outdoor music within the premises licence, the licence holders have requested the use of temporary event notices to allow for external music. On both occasions that this was requested in 2009, a number of complaints were received by Environmental Health.

#### 3. Recommendation (with conditions if appropriate):

I therefore recommend the addition of the following conditions to be included on the Premises Licence:

- A noise limiting device shall be installed, fitted and maintained in such a manner as to control all sources of amplified music at the premises so that it will be inaudible at neighbouring properties.
- An alarm shall be fitted to all external windows/ fire doors which alerts staff when they are opened without authorisation.
- No inflatable play equipment, and associated plant or machinery, shall be used after the hours of 19.00.

#### Re: The Royal Arms, Farnham

I write in relation to the above premises and the licence review that has been initiated by Surrey Police.

This Department, along with Surrey Police, has recently conducted two test-purchasing exercises on this premise. These were held on the 15<sup>th</sup> May 2009 and on the 4<sup>th</sup> September, which resulted in a sale of alcohol to male and female volunteers aged 15 & 16 years. As a result of these two separate incidents, a Fixed Penalty Notice of £80 was issued to Ms Emma Sharp and Ms Lauren Kane.

I wish to inform the committee hearing this review that the first test purchase was attempted after receiving intelligence from Surrey Police alleging the premises had been selling alcohol to under 18's. This Service acted upon this information and arranged with Surrey Police to test purchase at the earliest opportunity. The Royal Arms failed this test purcase attempt and served alcohol to two female volunteers aged 15 and 16 years of age. The second test purchase attempt was made because it had failed the last time out and as we do with all premises that fail a test purchase we re-visit to check for compliance and fully expect the management to have made changes to ensure no further under age sales are made. This would be confirmed by the premise passing the test purchase attempt, however this was not the case and again two volunteers working for this authority, one 16 year old female and one 15 year old male were successful in buying an alcoholic beverage each.

Both the operations successfully identified that the intelligence was correct and that the Royal Arms were not complying with Section 146 of the Licensing Act 2003. Even though Surrey Police take the lead on on-licence sales it appeared to the Trading Standards Officer leading the operation Mr Robert Towers, that after his conversation with The Seller(s) that even though there was some evidence of a minimal system being in place to prevent illegal alcohol sales, they were not being managed correctly and the DPS is ultimately responsible for that.

I hope this information assists the licence review process. If I can be of any further assistance then please do not hesitate to contact me.



During the summer a large concert was held featuring many local bands which was well attended and made a large amount of money for the above cause. All was wrapped up by 8 pm and everyone went home happy. Mr. Stubbings runs three darts teams throughout the year which he supports both by providing the facilities and in being involved in the organisation of the teams. He also joins in holding a Pie and Pint club for the locally retired. This is a very popular occasion and is appreciated by those who come.

Mr Stubbings has many guests throughout the year, a number of which return whenever they are in the area. Since November 2008 Mr Stubbings has opened up his facilities as a cafe in the mornings, a well used service by local people and those passing through.

On the very rare occasion that there has been inappropriate behaviour Mr Stubbings has been swift to act and to defuse the situation. I have never personally felt threatened in the 15 months that I have been a resident. I understand that Mr. Stubbings has been discovered serving alcohol to under-age customers on two occasions, but he has taken quick action to ensure that this does not happen again, particularly by using a a strict over-25 policy.

During my period here as a resident I have been visited by friends and family, usually for a weekend stay. They have all found it a welcoming community, from everyone, customers and staff and have enjoyed their time here. They all look forward to returning in the future and some already have.

It would be a great shame if for whatever reason the Royal Arms ceased to remain a public house, with Mr. Stubbings at the helm both for the community of Heath End, the surrounding area and myself.

#### ROYAL ARMS PUBLIC HOUSE HEATH END

#### Licence renewal

With reference to the above we would like our comments to be taken into consideration at the December licensing meeting.

- Rubbish bins overflowing outside the pub for at least two days before the Refuge collection is due, often the rubbish falls onto the public footpath and highway. There is food waste in the rubbish which can attract foxes foraging for food. This could also be a possible contributor to the occasional sitings of rats in the area.
- It appears that there is now a facility for local dumping on the ground adjacent to the main car park. Currently there is a large rubbish pile which has general builders rubbish, pallet boards and furniture on it.
- Whilst it is very commendable to hold fund raisers for charity there is no consideration taken into account of the suitability or location of the venue i.e. the Pub is surrounded by residential dwellings. There has been absolutely no communication to the near neighbours of forthcoming charity events or any other functions. The first we know about it is when we hear the unacceptable noise level.

In summary the Pub has become an eyesore with the rubbish in the carpark, the assortment of different signs on and around the periphery of the building and the overflowing rubbish bin on the pavement.

The majority of customers the Pub seem to generate and encourage is not conducive for what is a predominantly residential area. We have experienced disturbances in the carpark with shouting and foul language during the Pubs opening hours and after the Pub has closed its doors.

Taken all the above comments into consideration we can only assume that Mr Stubbings has a total disregard and respect for his immediate neighbours and the community he lives and trades in.

#### Dear Sir/Madam

I am writing to object to the renewal of the licence for the Royal Arms pub, Farnborough Road, Farnham.

As a resident of the surrounding area I have grown increasingly concerned with the way the pub is being run.

In the past 18 months there have been many altercations in the pub car park and in the roads around the pub, there seems to be a lack of respect for the residents as there is no effort made to try to keep noise levels to a minimum when customers are leaving the pub late at night.

In the past there has been numerous bouncy castles running on generators from 9am to 11pm.

At least once a month a group of at least 20 car fanatics meet up in the car park revving their engines and wheel spinning up the road until 10pm. A landlord conciderate to his neighbours would not allow this to happen.

More recently there has been a massive amount of rubbish dumped in the car park and garden by commercial vehicles and then burnt consecutively for about 8 days covering the neighbours houses and gardens with smoke so thick they are unable to use their gardens or have windows open.

There has also been rubbish dumped by commercial vehicles and buried in the grounds of the pub.

The landlord shows no consideration for his neighbours, of which he has many, and never informs them of any events or projects which effect the local community.

The reputation of the pub locally is very poor, and ultimately the brewery or whoever owns the pub should be accountable for its current state, of which they are unaware or they just don't care.

In response to a recent article in the Farnham Herald where the landlord has suggested the local community is upset by the installation of a cctv camera, nothing could be further from the truth, we welcome the camera and hope that some of the activities in the car part are recorded.

#### Licence Review for the Royal Arms, Farnborough Road, Farnham

With regard to the article in the Farnham Herald, 30<sup>th</sup> October, we hope that our comments will be considered.

There have been a number of factors that we have become very concerned about, listed below:-

- Rubbish regularly overflowing into neighbour's garden. Sightings of rats during the summer coming from under the pub fence.
- Concern over the continual burning of various materials (including plastic furniture) where fumes and debris are blown into nearby gardens.
- Garden unsafe for children The bouncy castles are falling apart with no safeguards or floor mats & the trampoline has broken nets. During the summer there were broken go-carts and garden furniture piled up in an unsafe heap.
- On a few occasions music has been played at an unacceptable level. When
  followed up with the environmental agency we were told the events were
  licensed (without any time constraints) which we find staggering considering the
  close proximity to residential / family dwellings.
- Up to three bouncy castles being left inflated throughout the day & evening during the summer months causing significant noise disruption from the generators.

### Re: Review of licence of The Royal Arms, Farnborough Road, Farnham

We feel that the following information is relevant for consideration in the review of the above license.

- Events where music has been played in the garden at unacceptable levels (reported to Environmental Health). Recently these have been as a result of TENS being issued, which is staggering considering the history of disruption from the premises. This history does not seem to have any impact on consideration for TENS being granted.
- Instances of individuals shouting and arguing abusively in the car park, obviously under the influence of alcohol.
- Up to 3 Bouncy Castles inflated, often being left on until late into the evening, and placed next to neighbour's fence.
- The establishment looks a complete eyesore, with posters outside the pub ripped, pieces of scrap MDF displaying offers, and rubbish left over flowing from bins.
- More recently, we have serious concerns at the amount of rubbish and debris being brought to the site for disposal and/or burning. It appears that local trades persons or businesses are bringing this, and then either burying it in the garden or burning it. The bonfire, which was lit for Bonfire celebrations, smouldered for 3 days.

In the article, Mr. Stubbings said, "a lot of my neighbours have been upset by the pod camera." His neighbours are delighted with this recent development, and hope that it continues, since it only films the pub, there can be no cause for concern from neighbours.



### 11. Reviews

#### THE REVIEW PROCESS

- 11.1 The proceedings set out in the 2003 Act for reviewing premises licences represent a key protection for the community where problems associated with the licensing objectives are occurring after the grant or variation of a premises licence.
- 11.2 At any stage, following the grant of a premises licence, a responsible authority, or an interested party, may ask the licensing authority to review the licence because of a matter arising at the premises in connection with any of the four licensing objectives.
- 11.3 In addition, a review of the licence will normally follow any action by the police to close down the premises for up to 24 hours on grounds of disorder or noise nuisance as a result of a notice of magistrates' court's determination sent to the licensing authority.
- 11.4 Licensing authorities may not initiate their own reviews of premises licences. Officers of the local authority who are specified as responsible authorities under the 2003 Act, such as environmental health officers, may however request reviews on any matter which relates to the promotion of one or more of the licensing objectives.
- 11.5 Representations made by a department of the local authority which is a responsible authority should be treated by the licensing authority in precisely the same way that they would treat representations made by any other body or individual.
- 11.6 In every case, the representation must relate to particular premises for which a premises licence is in existence and must be relevant to the promotion of the licensing objectives. After a licence or certificate has been granted or varied, a complaint relating to a general (crime

- and disorder) situation in a town centre should generally not be regarded as a relevant representation unless it can be positively tied or linked by a causal connection to particular premises, which would allow for a proper review of the licence or certificate. For instance, a geographic cluster of complaints, including along transport routes related to an individual public house and its closing time could give grounds for a review of an existing licence as well as direct incidents of crime and disorder around a particular public house.
- 11.7 Representations must be in writing and may be amplified at the subsequent hearing or may stand in their own right. Additional representations which do not amount to an amplification of the original representation may not be made at the hearing.
- 11.8 It is important to recognise that the promotion of the licensing objectives relies heavily on a partnership between licence holders, authorised persons, interested parties and responsible authorities in pursuit of common aims. It is therefore equally important that reviews are not used to drive a wedge between these groups in a way that would undermine the benefits of co-operation. It is good practice for authorised persons and responsible authorities to give licence holders early warning of their concerns about problems identified at the premises concerned and of the need for improvement. A failure to respond to such warnings is expected to lead to a decision to request a review.
- 11.9 Where the request originates with an interested party e.g. a local resident, residents' association, local business or trade association the licensing authority must first consider whether the complaint made is relevant, vexatious, frivolous or repetitious.

11.10 Further information for interested parties about the review process is available in "Guidance for interested parties: applying for a review" which can be found on the DCMS website.

#### REPETITIOUS REPRESENTATIONS

- 11.11 Relevance, vexation and frivolousness were dealt with in paragraphs 9.8 9.13 above. A repetitious representation is one that is identical or substantially similar to:
  - a ground for review specified in an earlier application for review made in relation to the same premises licence which has already been determined; or
  - representations considered by the licensing authority when the premises licence was first granted; or
  - representations which would have been made when the application for the premises licence was first made and which were excluded then by reason of the prior issue of a provisional statement;
  - and, in addition to the above grounds, a reasonable interval has not elapsed since that earlier review or the grant of the licence.
- of the need to prevent attempts to review licences merely as a second bite of the cherry following the failure of representations to persuade the licensing authority on earlier occasions. It is for licensing authorities themselves to judge what should be regarded as a reasonable interval in these circumstances. However, the Secretary of State recommends that more than one review originating from an interested party should not be permitted within a period of twelve months on similar grounds save in compelling circumstances or where it arises following a closure order.

- 11.13 The exclusion of a complaint on the grounds that it is repetitious does not apply to responsible authorities which may make more than one request for a review of a premises within a 12 month period.
- 11.14 When a licensing authority receives a request for a review from a responsible authority or an interested party or in accordance with the closure procedures described in Part 8 of the 2003 Act, it must arrange a hearing. The arrangements for the hearing must follow the provisions set out by the Secretary of State in regulations. The details may be viewed on the DCMS website. The Secretary of State considers it particularly important that the premises licence holder is fully aware of the representations made in respect of the premises, any evidence supporting the representations and that they or their legal representatives have therefore been able to prepare a response.

## POWERS OF A LICENSING AUTHORITY ON THE DETERMINATION OF A REVIEW

- 11.15 The 2003 Act provides a range of powers for the licensing authority on determining a review that it may exercise where it considers them necessary for the promotion of the licensing objectives.
- 11.16 The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such warnings as an important mechanism for ensuring that the licensing

objectives are effectively promoted and that warnings should be issued in writing to the holder of the licence. However, where responsible authorities like the police or environmental health officers have already issued warnings requiring improvement — either orally or in writing — that have failed as part of their own stepped approach to concerns, licensing authorities should not merely repeat that approach.

- 11.17 Where the licensing authority considers that action under its statutory powers are necessary, it may take any of the following steps:
  - to modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
  - to exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption);
  - to remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;
  - to suspend the licence for a period not exceeding three months;
  - to revoke the licence.
- 11.18 In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns which the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than a necessary and proportionate response.

- 11.19 For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.
- 11.20 Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated by representations, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems which impact upon the licensing objectives.
- 11.21 Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as a necessary means of promoting the licensing objectives. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing authority's decision is necessary and proportionate to the promotion of the licensing objectives.

## REVIEWS ARISING IN CONNECTION WITH CRIME

- 11.22 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises or money laundering by criminal gangs or the sale of contraband or stolen goods there or the sale of firearms. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts of law. The role of the licensing authority when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure that the crime prevention objective is promoted. Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. Some reviews will arise after the conviction in the criminal courts of certain individuals but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go behind any finding of the courts, which should be treated as a matter of undisputed evidence before them.
- 11.23 Where the licensing authority is conducting a review on the ground that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken

- place despite the best efforts of the licensee and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any necessary steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives in the interests of the wider community and not those of the individual holder of the premises licence.
- 11.24 As explained above, it is not the role of a licensing authority to determine the guilt or innocence of individuals charged with licensing or other offences committed on licensed premises. There is therefore no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. As stated above, at the conclusion of a review, it will be for the licensing authority to determine on the basis of the application for the review and any relevant representations made, what action needs to be taken for the promotion of the licensing objectives in respect of the licence in question, regardless of any subsequent judgment in the courts about the behaviour of individuals.
- 11.25 There is certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously. These are the use of the licensed premises:
  - for the sale and distribution of Class A drugs and the laundering of the proceeds of drugs crime;
  - · for the sale and distribution of illegal firearms;
  - for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected:

- for the purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people;
- for prostitution or the sale of unlawful pornography;
- by organised groups of paedophiles to groom children;
- as the base for the organisation of criminal activity, particularly by gangs;
- for the organisation of racist activity or the promotion of racist attacks;
- for unlawful gaming and gambling; and
- for the sale of smuggled tobacco and alcohol.
- 11.26 It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered. We would also encourage liaison with the local Crime and Disorder Reduction Partnership.
- 11.27 It should be noted that it is unlawful to discriminate or to refuse service on grounds of race or by displaying racially discriminatory signs on the premises. Representations made about such activity from responsible authorities or interested parties would be relevant to the promotion of the crime prevention objective and justifiably give rise to a review.

### REVIEW OF A PREMISES LICENCE FOLLOWING CLOSURE ORDER

- 11.28 Licensing authorities are subject to certain timescales, set out in the legislation, for the review of a premises licence following a closure order. The relevant time periods run concurrently and are as follows:
  - when the licensing authority receives notice that a magistrates' court has made a closure order it has 28 days to determine the licence review: The determination must be made before the expiry of the 28th day after the day on which the notice is received;
  - the hearing must be held within 10 working days, the first of which is the day after the day the notice from the magistrates' court is received;
  - notice of the hearing must be given no later than 5 working days before the first hearing day. There must be five clear working days between the giving of the notice and the start of the hearing.
