Summary and Purpose

1. The purpose of the report is to enable the Sub-Committee to consider an application from Southern Co-operatives Limited, for a new premises licence for Co-op, 47-51 Farnborough Road, Farnham, Surrey, GU9 9AJ where representations have been received from an interested party.

Background

2. An application has been received for a new premises licence from the Co-op who are due to operate from this premises (current operator - Bennets Electrical) to sell a range of goods. The application proposes that the licence will allow the premises to sell alcohol for consumption off the premises.

Activities Sought under this Licence Application

- 3. The applicant seeks to licence the premises as shown below. An extract of the relevant pages from the application form is attached at Annexe 1. Attached to this document at Annexe 2 are some amendments to the application following discussions between the applicant and Surrey police. Also attached at Annexe 3 is a plan showing the premises and surrounding properties. In brief summary, the applicant seeks the following activities in the new licence, if granted. Please see application for activities in full.
 - Sale of Alcohol0800 to 2300 Monday to Sunday
 - Opening hours: 0600 to 2300 Monday to Sunday

Licensing Objectives

What the Sub-Committee may do

Reasons must be given by the Sub-Committee for any decision made, since there is an opportunity for any applicant or any objector to appeal to the Magistrates' Court against the Licensing Sub-Committee decision. The Sub-Committee may:
 - Grant the application as submitted; or
 - Refuse the application; or
 - Reduce or refuse parts of the application submitted,
 - Add conditions to meet the Licensing Objectives if the Sub-Committee considers it necessary in the light of the representation received.
- 8. An extract from the Government Guidance to local authorities under Section 182 of the Licensing Act 2003, as it applies to this application paragraphs 9.19 to 9.28 is attached as Annexe 5.

Recommendation
