4. <u>LICENSING ACT 2003 - APPLICATION FOR A NEW PREMISES LICENCE –</u> 55-56 WILLOW WAY, FARNHAM, SURREY, GU9 0NT (Appendix A)

The purpose of the report at <u>Appendix A</u> is to enable the Sub-Committee to consider an application from Mr Deluxchem Rajkumar, for a new premises licence for 55-56 Willow Way, Farnham, Surrey GU9 0NT where 26 valid representations have been received.

Recommendation

5. <u>LICENSING ACT 2003 - APPLICATION FOR A NEW PREMISES LICENCE –</u> <u>WINKWORTH ARBORETUM, HASCOMBE ROAD, GODALMING, SURREY</u> <u>GU8 4AD</u> (Appendix B)

The purpose of the report at <u>Appendix B</u> is to enable the Sub-Committee to consider an application from National Trust (Enterprises) Ltd, for a new premises licence for Winkworth Arboretum, Hascombe Road, Godalming, Surrey GU8 4AD, where Representations have been received from 'other persons' and 'Responsible Authorities'

Recommendation

The Sub-Committee is requested to consider the application for the grant of a premises licence on its merits.

Having regard to the representations made, the Sub-Committee must take such of the steps outlined below (if any) as it considers appropriate for the promotion of the Licensing Objectives. Those steps are:

- To reject the application.
