To Whom It May Concern
I do not wish my details to be known as this would or could effect my current job role.

I have been a resident of Willow Way for about 9 years, I live within 30 seconds walking distance and walk past the now empty store nearly every day.

I am some what aghast to see for the first time today, one application form, stuck on the door of the empty shop stating that the new owners , are requesting that they be allowed to open from 6 am to 2300 hours everyday including Christmas day and to sell alcohol.

On the parade, there is a beauty salon and already a Newsagents / connivence store that sales Alcohol with limited hours. Which was strongly objected to 3 years ago and the council amended the given hours

I strongly object to the store location and opening times / selling of alcohol, having spoken to a number of other residents I believe you will be receiving more objections.

Willow Way is a quiet family orientated area, within easy reach of Tesco's express, Co-op, a main Sainsbury's (Farnham) and Tesco's (Aldershot), not to mention the numerous other local garages that sell alcohol and are open late at night.

The negative impact this will have on families with children and the elderly who live next to, above the store or like my self within close proximity will be huge and long lasting.

Like Tesco's Express, and the Co-Op it will attract the wrong sort of people. It will increase the risk of Anti - Social Behaviour and under age drinking, within an area that currently requires little police presence. The shopping area now is currently avoided by local resident's between the times of 1530 and 1615 due to the mass influx of school children who gather there when they leave school. Some of whom are clearly under age and

smoking as they are still wearing their uniforms. How will they stop underage drinkers either stealing the drink or finding other means to obtain it, the use of CCTV will not stop it as has been the case at Tesco's express

I am aware that residents have already complained to the local police about Anti Social behaviour on the parade which is now requiring a more active presence from local officers

A Co-OP store (on the main A325 Farnham Rd) not more than a 2 minute walk from Willow Way sales alcohol and has an 0700 - 2300 opening time time this is not in the middle of a residential area with deliverers nearly every day

I understand one of the reasons the Family run Window company which had been based in the unit for 20years or so was the delivery issues, as they had requested extra and this was refused.

So how could the council grant a store that will have more delivers every day to ensure fresh produce one would assume to compete with the Co-op also the Co-op has it own parking, there is neither the room for large Lorries or customer parking in our close

There is no benefit whatsoever to our community in this application if the Council allow this to go ahead.

If the application is granted, I trust the Council will take full responsibility and be held accountable for the negative impact on their constituents, the increased police presence, time and money that will undoubtedly follow, not to mention the detrimental affect on house prices within the area, the increase of crime such as criminal damage to property both by physical damage and that of unrine, and the safety of their local residents, particular the elderly all of whom will feel less inclined to leave their own homes for fear of drink related violence.

I said to Kate, the Government wishes that the people have more power to say about how local issues and decisions about their community effect them and how the council should listen and act accordingly. Also having only read on the BBC website about NICE, the watchdogs comments about local councils saturating communities with unwanted shops, takeaways etc and how the council should consider what the committee wants before allowing shops to sell alcohol, the hours they are open, the days they are open and what time they can actually sell alcohol.

It went on to explain about the cost that is then incurred by the NHS of £2 billion a year due to drink related care, either by violence or alcohol poisoning of underage drinkers and the cost in lives15,000 I believe it stated.

I think you are or should be aware of the feelings of this community and the detrimental cost it will have on health as well as the financial impact. I understand from a local estate agent this will reduce the cost of each local house by a minimum of £10,000.

I have every intention of being at any pending meeting, if I am not required to be on duty at work that day. I am a father of two young sons and am extremely concerned about the antisocial behaviour they could be exposed to.

As to the four licensing objects, I feel that all of them are part of my objection but particularly crime and disorder. If I were to list them they would be in the following in order:

- 1. Prevention of crime and disorder
- 2. Protection of children from harm
- 3. Prevention of public nuisance
- 4. Public Safety

Put simply, please do not grant this application; our community does not want or need it.

I would like to object to the license application for Costcutter at 55-56 Willow Way, Farnham on the following grounds:

Prevention of crime and disorder - Selling alcohol late into the evening will encourage drunken behaviour and lead to an increase in crime and disorder in a peaceful residential area.

I strongly object to the issue of a license for the sale of alcohol under the Conditions detailed on this Application, in that they are not good enough to prevent crime and antisocial behaviour in this residential area. The conditions state that Willow Way is not principally a residential area, which is clearly not true, as there are 85 residential houses in the estate and only 4 shop units, which originally were for the benefit of the residents. Willow Way is clearly a residential area and it must remain so. There are houses facing 55-56 Willow Way and there are residents all around and the last thing we want is a shop opening all hours with the commotion and traffic problems. There isn't enough parking already for what is proposed.

Willow Way is a through route for children on way to Heath End School and William Cobbett Junior School. Large numbers of children up to age 18 gather in Willow Way before and after school, so it is of paramount importance to protect the children. Willow Way must also be protected from the public nuisance of alcohol related crime, as there are lots of alleyways where people could gather and generally make the place unsafe for the children of residents to play.

We are a residential area and we enjoy peace and quiet in this neighbourhood. We do not need a shop opening at 6am till 2300 hours, in fact that is antisocial in itself. We do not want a shop, which opens these hours, causing a disturbance with delivery lorries and traffic. We have plenty of convenience stores as well as the larger Tesco, Sainsburys, Morrisons all nearby, so a convenience store we just don't need in this residential area, especially with the sale of alcohol, and the associated problems of litter, nuisance behaviour, extra traffic and parking problems.

I am writing to object to the proposed issue of a licence for the sale of alcohol under the conditions and for the opening hours detailed on the application. My reasons are:

They are inadequate for prevention of public misance,
Inadequate to protect local children from harm,
Inadequate to prevent crime and disorder,
And also to ensure public safety.

I note that Willow Way is described as "not principally a residential area" and this is not the case. Willow Way is very much a residential area, along with the surrounding area of The Avenues (North, South, East and West), Rushden Way and White Cottage Close.

The area containing small shops at 53, 54 and the proposed 55-56 Costcutter are the only non residential

properties and even they have residential properties above them.

I would also point out that the Newsagent at 53 Willow Way already has an Off-Licence for the sale of alcohol and his shop is frequented by children travelling to and from the local schools. Local residents battled long and hard to restrict the Newsagents licensing conditions and hours during which alcohol may be sold and this appears to have been successful in preventing disorderly behaviour in the vicinity. The Costcutter licence should be subject to the same conditions. It does however raise the question of whether there is a need for two Off-Licences practically next to each other in an otherwise residential area. I would also point out that there is a Co-op supermarket within half a mile, also selling alcohol. In my opinion this is overkill!

In the event of a Costcutter shop being opened, I would also point out that parking and traffic management for Willow Way will require a rethink, as the area is quite restricted for space now, and that is with the present shops in use. (Nail care at 54 and News Agent at 53). The previous owners of 55-56 were a double glazing firm; none of these attracted the kind of customer throughput which can be expected by a supermarket.

Dear Sirs.

As with the previous licensing application for the neighbouring newsagent (no. 53) who already has an alcohol licence, the main concern with the residents is 'prevention of public nuisance'.

This is (contrary to some information) a <u>98 percent residential area</u>. Already somebody is attempting to distort/misrepresent facts for this application.

The license for the existing newsagent (no.53) does 'contain' the potential issues, and there is no reason as to why a neighbouring shop should have any different conditions, if at all.

A 'more lax' license was granted many years back, to a for his supermarket on that site, police records, and objections to the licence continuation, clearly show how:

a semi-covered area, lit at night, selling alcohol till late, with nothing to prevent older kids buying for the inevitable gathered groups of youngsters, quickly degenerates to rowdiness, drunken behaviour, random criminal damage, noise, and then .... at the dark area behind (car park/loading bays), fast hatchbacks delivering/exchanging small packages to members of the groups in the darker hours. The situation is absolutely ideal for the drug pushers, who used the opportunity very regularly, and seemingly without fear of being ever caught.

There is no exaggeration in that previous paragraph.

Now of course, the use of mobile phones can very quickly change a steady situation, into a storm.

Previously (in the days) word spread quickly, that on some evenings, only one or two youngsters were actually staffing the shop. There was very little they could do to prevent the mass shoplifting that took place on those occasions (including bottles of whatever was at hand).

The local residents, those who surround the shop, those who faced the shop, and those who lived above the shop, could do virtually nothing to prevent the loud nasty language, the litter, the broken glass, the urine in the alleyways, the pavement vomit, or the threats of vandalisation, particularly if the objector was named or recognised.

The area in front of the shops was designed as a pleasant place for meeting, a children's play area, and an open space in the centre of over 100 houses. A late night shop, especially one that has almost free reign on alcohol sales, quickly destroys all of the above.

#### As a secondary point:

Should the "Costcutter" store become as popular as the Tesco Express at Upper Hale, one fails to see how any extra parking could be provided, and without it, parking for residents and their visitors would be severely affected. Willow Way itself is just not positioned or constructed for traffic as heavy and frequent as any Tesco Express custom.

So I strongly object to the issue of a license for the sale of alcohol, under the conditions and for the opening hours, as detailed on this application.

I would ask you, urge you even, to either actively discourage the applicant from setting up shop, or at the very least, apply exactly the same tight, policed, licensing restrictions to the alcohol sales, as per the newsagent's. You will be letting us, the Council Tax payers, down badly, should this go ahead as requested by the applicant.

Please make it your business to visit Willow Way, look around the premises, and imagine how loose licensing could turn the area "bad" again, very quickly.

If late night alcohol is legitimately required, there is a licensed Co-Op on the Farnborough road nearby, and a Tesco and Sainsbury's within two miles of Willow Way. At least those are not bang in the centre of a residential estate, and have the staffing and defined areas to contain any problems, as/when they occur.


I have been a resident at Willow Way for over 40 years, and have seen many local changes, and know Willow Way history better than most, as I am overlooking the relevant locations.



We already have within easy walking distance of Willow Way a Co-op mini supermarket selling newspapers, groceries and alcohol in addition to the local licensed newsagent on Willow Way itself which sells some convenience supplies. We fear that the intrusion of an additional chain store will jeopardise the future of the local newsagent who provides an excellent newspaper delivery service.

If the application is allowed we would expect that the restrictions on the sale of alcohol would be as restrictive as those applied to the newsagent in Willow Way. The small shopping precinct in Willow Way is a favourite gathering place for schoolchildren at certain times of the day and that is why it is important to have appropriate restrictions on the sale of alcohol.

We received information about this application through our local Neighbourhood Watch co-ordinator. We have not been able to find the application on your website (www.waverley.gov.uk). However, we understand that in conditions relating to the application Willow Way is referred to as "not principally a residential area". With over 80 houses and provision for 3 or perhaps 4 shops we would like to refute vigorously any suggestion that it is anything other than a residential area.

I am writing to inform you of my strong objection to the issue of a License for the sale of alcohol under the conditions and hours put forward in this application. I object in that they are inadequate to prevent crime and disorder, inadequate to ensure public safety, inadequate to ensure the prevention of public nuisance and inadequate to ensure the protection of children from harm.

The conditions state that this area (Willow Way) is not principally a residential area which I find astonishing. Willow Way is clearly a housing estate and there are flats above the premises and at least eight houses within ten metres of the property in question. It is clearly an area inhabited by many young families and retired people. The area where this premises is located is pedestrianised and, as a result it is already an area that attracts loitering on occasions at night, particularly during the summer months. The nature of the area and a newsagent in the parade makes this a popular area for school children to meet and play, particularly before and after school hours.

The newsagent mentioned above applied for a license to sell alcohol and does so under stringent guidelines, the main ones being that, the sale of alcohol should cease at 6pm and that alcohol should be kept behind the counter. I think that the current application should have terms at least as stringent as those applied to the newsagent at No. 53 Willow Way.

As a parent with a two year old child I am extremely concerned about the prospect of alcohol being sold so late into the evening as I am certain it will cause increased noise, litter and loitering in the area. If groups of friends know they can pop into the Costcutter for a few cans of beer as late as 11pm and then sit on the outside wall to drink them it will inevitably become a magnet for people to gather and, with alcohol consumption comes antisocial behaviour and litter. I really do not want my daughter to grow up in an area where this can happen.

I would prefer if the opening hours for the shop were also reduced to earlier in the evening than 11pm as, even without the sale of alcohol, there with be increased noise and traffic in the area late at night.
