Re Notice of Application for a premises Licence at 53 Willow Way, Hale, Farnham, Surrey GU9 0NT to include the sale of retail by alcohol.

We would like to register our strong objection to the above application for the following reasons:-

- 1. Willow Way is a residential area, which should be protected.
- 2. We have enough trouble with youths in the area already and if we have a shop open till late, the problem is going to get worse for the residents.
- 3. The problem would get worse in the summer with youngsters going to Farnham park, where they drink and get up to other unsociable behaviour.
- 4. There are enough shops within a mile or so that sell alcohol already.
- 5. It would affect too many residents. Some people have trouble getting to sleep sometimes with youths hanging about there already making a nuisance of themselves.
- 6. We are afraid that it will lead to people hanging about in the alleyways drinking and carrying on and generally causing trouble and a nuisance, fuelled by alcohol.
- 7. Willow Way is easily accessed by side roads and footpaths, which would make illicit drinking more easy.
- 8. It is also the access route to Farnham Heath End Secondary School, so an alcohol license would be very unsuitable.
- 9. Willow Way is not zoned for Restaurants, off licences and the like.

- 10. An alcohol license would effectively turn this shop into an off license.
- 11. A large number of residents face onto the shops. It is essential for these people that shops are shut early, so we would also oppose extended hours of use.

We most strongly object for all of the above reasons. We don't want alcohol sold in Willow Way. We don't want shops staying open longer than 5.30pm at night. We want to keep it that way and sincerely hope that this application will be refused for the sake of ourselves and the neighbourhood. There is no benefit to Willow Way to have alcohol sold at the newsagent, rather the opposite.

We are writing to you to raise our objections to the application detailed above.

The premises are within a quiet residential area and totally unsuitable to be open for business until 23:00 every night of the year, even without a licence to sell alcohol.

Having a shop open to such late hours would undoubtedly attract youngsters and noise, which would cause much concern to the local residents, particularly those living in numbers 57 to 60, 46 to 52 Willow Way, and also those living in the flats above the shops.

In fact in the past during the summer months, there have been many occasions when youths have gathered in the evenings outside the shops (none of which were open) and have caused disturbances and irritation to local residents. On one such occasion the large glass front window in E.J. Nash's shop was actually broken by the activities of unruly youths.

Also, in our estimation, apart from the sale of newspapers, the patrons of E.J. Nash Newsagents are predominantly schoolchildren.

With regard to the availability to purchase alcohol, Willow way is close to the Tesco Express store in the Hale Road and the Sainsbury's store at Water lane. So in our opinion, there is absolutely no requirement for another shop in the local area to sell alcohol.

In conclusion, we feel that in quiet residential area, having a late opening shop, especially one that sells alcohol, is totally and utterly unsuitable and unacceptable to us and probably to the majority, if not all, of the local residents.

It has come to my attention that the new owners of the newsagents have applied for an alcohol license. My first concern over the nature of their consideration to us as residence took place at 7.30 yesterday morning (Sunday) when I was woken up by their van delivering new furniture for the shop woke me up while crashing the furniture and chucking it on to the road in a most inconsiderate way.

Being a busy through road we are already subject to noisy and anti-social behaviour late at night (In particular young people in cars reeving their engines), I can only see that providing another place for people to "hang around" whilst consuming alcohol will make it a very unpleasant place to live. I understand that an application has been made to Waverley Borough Council for a new licence to use the above premises for the sale by retail of alcohol.

As a long term resident of Willow Way (since October 1967), I feel that the licence should not be granted. My principal objections are as follows:

- 1. A retail outlet for the sale of alcohol is not appropriate in a predominantly residential estate;
- The possible negative Impact on residential values in Willow Way if the licence is granted (for most residents the family home is their key asset, even in a faltering housing market);
- 3. The potential for creating an environment for anti-social behaviour and crime, including litter and fouling of streets;
- 4. Potentially additional traffic and parking issues through limited access, (already above average as a result of "A Touch of Glass" window business operating in the same group of premises) which may cause additional risk to young children;
- 5. Creating an opportunity for under age consumption of alcohol by pupils of Heath End and other local schools:

I believe the above to clearly indicate that the granting of a licence for the sale of alcohol would breach the Borough Council's fundamental licensing principles.

Dear Sir,

It has come to my attention that the owners of the shop at 53 Willow Way, Farnham, Surrey, GU9 0NT have applied for a new license which includes the sale of alcohol.

I would like to strongly object to this application on the following grounds:

1) prevention of public nuisance

Willow Way is a quiet residential road, especially in the evening, and we want to keep it that way! For this reason planning applications to use the shops in the evening hours for take-away food and as a restaurant have been refused in the past.

The shop already creates a litter problem, as scores of schoolchildren use on their way to and from school, then discard their sweet wrappers, cans and bottles in the street. Increased trade and extended opening hours would make this problem worse.

Large numbers of children congregate outside the shop during the afternoon. It can be intimidating to older residents to see 20 or more of them making their way down the street. Thankfully the shop is currently closed in the evening. If alcohol was on sale in the evening, older youths would also congregate outside the shop and create noise and disturbance in the evening affecting local residents.

There is currently no graffiti / vandalism in Willow Way, but this is unlikely to remain the case if alcohol can be bought and consumed locally.

2) protection of children from harm

At the moment, the shop is primarily a children's sweetshop. It does not seem like a good idea to allow alcohol sales in such a shop, as no doubt older youths would buy alcohol for younger ones waiting outside the shop.

The Willow Way road is usually very quiet, apart from twice a day when it is briefly used as a rat run by parents taking their children to/from school. As it is so quiet, local children often play in the street. If the shop stayed open longer and sold alcohol, the road would have much more traffic and these children would be in increased danger of traffic accidents.

This would be very detrimental to my children's safety, increase in teenagers hanging around, which is already a problem when they congregate outside the shop in the day time, last week my 10year old daughter was

jeered at by a group of boys outside the shop in a threaten behaviour. As I have 3 children this is a grave concern especially with the long opening hours that more young adults would be hanging about, especially should they be under the influence of alcohol. Which is not what I want my 3 young children to be influenced by. We have many children in willow way under the

age of 11yrs who like to play out with each other and ride their bikes and enjoy a relative amount of freedom, with the increased opening hours and selling of alcohol this means that would have to be stopped due to increased

traffic and the possible drunk !!!

Public safety would be compromised as their is insufficient parking for residents cars currently, customers would be parking and turning where children would be playing including pavements. Tesco express is less than half a mile away I feel there is absolutely no requirement to sell alcohol on these premises in willow way. I have been witness to some very unsavoury behaviour outside tesco express with people obviously drunk and fighting, shouting act and generally being a public nusiance. We bought our house 3 years ago the shop was one of my main concerns, I was reassured because of the short opening hours, I would have not bought the house if alcohol was being sold. Am concerned that inevitably the selling of alcohol on these premises could ultimately effect our hose prices.

One of our area's greatest concerns about behaviour outside school is linked to the abuse of alcohol by young people, particularly those of school age. Indeed we are active partners in the SW Area Alliance Executive working group on the mis-use of alcohol.

In this context I have concerns that granting a licence increases the availability of alcohol to the public including young people, when there are already enough licensed premises in the area. I understand that the already established off license, 'Threshers' on the Farnborough Road at Heath End is changing hands to become a cut price alcohol shop.

E.J. Nash is used by a large number of our students on their way to and from school. In the past we know there have been security issues where students have stolen items, including tobacco from the shop. Just two months ago we received a call from the current owner reporting that a number of students had been rude to him and were stealing sweets from the premises. My Deputy Headteacher paid Mr Shanmugarajalingham a supportive visit. When my Deputy asked about CCTV pictures to identify any students he was told by the owner that CCTV was too expensive and that it was not worth it for a few sweets. My Deputy also remarked that the shop layout was not conducive to good security and that the shop owner appeared to have no methods of controlling to children in the shop. We notice too that the hours of opening seem excessive for a residential area.

We would therefore object to the premises having an alcohol license, but if one were to be granted I would like to be assured that appropriate systems are in place to ensure that students could not obtain alcohol through purchase by older brothers/sisters or by theft from the shop.

We are very much opposed to the application for an alcohol license at EJ Nash newsagents, 53 Willow Way for the following reasons;

- 1. We have young children who play outside in safety at the moment- apart from the odd incident when youths hang around at the newsagents. If the shop is open until 11pm at night, this will incur cars, pedestrians coming into a quiet close at all hours. We are very concerned about the amount of public disorder this will bring to our neighbourhood.
- 2. Tesco Express is less than half a mile away selling alcohol. Why do we need somewhere else selling alcohol? I have been to Tescos at night and felt very intimidated by the youth element hanging around. We do not want that on our doorstep. We wouldn't have bought our house here otherwise. Will the new owners give us the money we will lose for the value of our property out of their profits for selling alcohol?
- 3. Threshers was situated on Farnborough Road selling alcohol and has shut down recently- why not use these premises for the selling of alcohol, where the area is less residential?
- 4. We bought our house in good faith that an alcohol license had been turned down in the past. Obviously those reasons are still valid.

I am writing to object to the application for a premises licence to include the sale of alcohol, at 53 Willow Way, Farnham, Surrey. GU9 0NT.

I live only a few yards from the premises concerned and have had experience of the adjacent premises selling alcohol when it was a supermarket. We experienced many bottles and cans being thrown into our front garden and, as we live next to a footpath, the bottles and cans were also thrown into our back garden. Quite often these containers were not completely empty, which made the job of clearing up both messy and possibly harmful to our health. We also experienced half full beer cans being thrown at our house, one damaging the front door which was made of wood and luckily not glazed. As you can imagine this made us feel very threatened and unwilling to confront the perpetrators, who ran off anyway. Late night noise and bad behaviour were other problems experienced due to drinking "gangs".

My wife worked at the aforementioned supermarket on Saturdays for a short period of time before it closed and experienced many problems with youths and under aged drinkers. Please note that the area in front of the shops is a traffic free zone where younger children play and I feel that those children would be put at risk by the proximity of alcohol to their play area and the drinkers of alcohol. Further to this the premises is used on a daily basis during the week by school children both going to and returning from school. I have seen a few of them smoking so is there any guarantee that some of them might not be influenced to try alcohol too?

In this residential road it is quite ridiculous for this type of shop to be open until 11 pm every day of the week, and, as a Christian, I find it disgusting that anyone should wish to open for the same hours on Christmas Day, even Tesco do not do that!

I have been a resident of Willow Way for about 7 years and a regular customer of NASH newsagents, I live within 30 seconds walking distance and walk past the store nearly every day.

I am some what aghast to see for the first time today, one of (what appears to be) only two pink application forms, some distance from the shop; stating that the new owners (having only taken ownership this week on Wednesday 26th June), are requesting that they be allowed to open to 2300 hours everyday including Christmas day and to sell alcohol.

I strongly object to this, having spoken to a number of other residents I believe you will be receiving more objections.

Willow Way is a quiet family orientated area, within easy reach of Tesco's express, a main Sainsbury's (Farnham) and Tesco's (Aldershot), not to mention the numerous other local garages that sell alcohol and are open late at night.

The **negative** impact this will have on families with children and the elderly who live next to, above the store or like my self within close proximity will be huge and long lasting. (I am aware that the new owners have rented one of the flats above the store itself).

Like Tesco's Express, it will attract the wrong sort of people. It will increase the risk of Anti - Social Behaviour and under age drinking, within an area that currently requires little police presence. The shop now is currently avoided by local resident's between the times of 1530 and 1615 due to the mass influx of school children who gather there when they leave school. Some of whom are clearly under age and smoking as they are still wearing their uniforms. 

Objection to Premises License for E J Nash Newsagents.

I would like to object to the application for E J Nash Newsagents in Willow Way, Hale, Farnham to have permission to expand their business to sell alcohol.

I object on many counts which I shall list below but for the record I live very near to the Newsagent which is positioned within a residential area and is fronted by a square.

Willow Way is in a residential area and not on a main road, an alcohol licence would encourage more traffic through the streets and with many young children around this could be dangerous.

Children currently use the square to play football, learn to ride their bikes etc, it would not be appropriate to have an outlet to sell alcohol from there because alcohol outlets attract groups of young people and underage drinking.

This is not to say that the owners would knowingly sell alcohol to underage children but there are always ways of young people getting hold of it from other over 18 year olds.

The Square would become an area for people to hang around until late in the evening and I am fearful of the amount of beer cans, glass bottles etc that would be left or smashed on the square. This would be a danger to children and animals.

I am also fearful of the increase in noise within this residential area that would be inevitable from both traffic and people drinking through the night.

As we know drinking and criminal behaviour can go hand in hand, I expect that there would be an increase in crime if this alcohol licence was allowed in this quiet residential area.

There is an existing Tesco Express on the main road that does sell alcohol, this is by the traffic lights in Hale and has specific parking to manage increased customers and CCTV to monitor any criminal behaviour or domestic disturbance..

There is also a pub/ restaurant within walking distance of Willow Way on the main Hale road again with its own parking for customers.

Willow Way is not on a main road, there is minimal existing parking for the current newsagents and residents and often cars are double parked which can be dangerous. There would be no security to protect the residents and the properties around Willow Way and as a result we would be vulnerable to the consequences of alcohol sales.

Talking to residents who lived in Willow Way when there was a premises which sold alcohol, I understand that there was an increase in house crime, car crime and graffiti, I would expect there to be the same if not more if this licence is granted.

As we know some young people and their drinking habits are being targeted by our new government to minimize the health and social risks that they have. As a result it would seem a retrograde step to allow alcohol sales from a quiet residential area.

I would be grateful if you would acknowledge receipt of my objection.

I have received numerous representations, both written and oral, regarding this application, and am therefore writing to you to add my weight to the objectors' case.

There are several reasons I have been given for their objections, some of which I suspect are not strictly relevant to the argument, however the key concern and one which I would wholeheartedly support is the likely increase in noise nuisance in the evenings.

The shop in question has traded under various ownership for many years, and is heavily used by schoolchildren both on their way to and from school, and after school and in the holidays. As is so often the case with young people, they have a tendency to congregate, mess about and chat, all of which is perfectly innocent in itself but which can create significant disturbance to others without the young people in question necessarily realising. The noise nuisance is well contained at the moment as the shop currently closes at 18.00 and any young people who may have been "hanging around" on the square outside the shop will then disperse, however it is my understanding that this application it to open to sell alcohol until 23.00 and it is this that is likely to cause a problem.

Certain of the objections I have received mention the proximity of alternative premises and also the poor mix of children and alcohol, however I believe these not to be matters which can be taken into consideration, the latter in particular being a matter for the licence holder to ensure does not occur, however the underlying issue in all objections is always that of the noise nuisance.

The shop sits on a square, directly opposite houses only a few yards away and in close proximity to many other houses immediately surrounding the square, and it is these neighbours who would suffer the brunt of any disturbance. There is also very limited parking nearby, and the likely additional traffic visiting the shop were it open in the evenings would both increase the noise and increase pressure on the already limited parking spaces.

I would like to request that the committee refuse this application on the grounds of disturbance to neighbours, and were it minded to grant the licence that it should limit the hours of operation to 18.00 to minimise the noise nuisance.

As a single mother with a 13 year old teenage son and an 11 year old daughter I strongly object to a licence being granted for the use of the premises at E J Nash Newsagent 53 Willow Way, Hale, Farnham, Surrey, GU9 1HR to include the sale of alcohol and to be open every day and to such late hours.

I understand the "Licensing Objectives" and my objections fall into all of the categories. There have been incidences in the past when there was a supermarket in the row of shops which had a drinks licence and long opening hours. Drinks being sold and I also understand on some occasions being stolen from the supermarket caused problems with legal and underage drinkers who would hide in corners or congregate on parts of Willow Way. This resulted in dangerous litter including cans and bottles being left on the estate plus an increase in criminal damage to property and vehicles.

We wish to object to the issuing of a licence at the above premises which would include the sale by retail of alcohol.


We are long term residents of Willow Way having lived at our current address above since 1981.

The availability of alcohol at this location would increase the opportunity and temptation for older teenagers to buy alcohol for underage schoolchildren.

- 9.12 The Secretary of State recommends that in borderline cases, the benefit of the doubt should be given to the interested party making the representation. The subsequent hearing would then provide an opportunity for the person or body making the representation to amplify and clarify it. If it then emerged, for example, that the representation should not be supported, the licensing authority could decide not to take any action in respect of the application.
- 9.13 Licensing authorities should consider providing advice on their websites about how any interested party can make representations to them.

DISCLOSURE OF PERSONAL DETAILS OF INTERESTED PARTIES

- 9.14 Where a notice of a hearing is given to an applicant, the licensing authority is required under the Licensing Act 2003 (Hearings) Regulations 2005 to provide to the applicant with the notice and copies of the relevant representations that have been made.
- 9.15 In some exceptional and isolated circumstances interested parties may be reluctant to make representations because of fears of intimidation or violence if their personal details, such as name and address, are divulged to the applicant.
- 9.16 Where licensing authorities consider that the interested party has a genuine and well-founded fear of intimidation and may be deterred from making a representation because of this, they may wish to consider alternative approaches.

- 9.17 For instance, they could advise interested parties to provide the relevant responsible authority with details of how they consider that the licensing objectives are being undermined so that the responsible authority can make representations if appropriate and justified.
- 9.18 The licensing authority may also decide to withhold some or all of the interested party's personal details from the applicant, giving only enough details (such as street name or general location within a street) which would allow an applicant to be satisfied that the interested party is within the vicinity of the premises. However, withholding such detail should only be considered where the circumstances justify such action and the licensing authority is satisfied that the complaints are not frivolous or vexatious.

HEARINGS

9.19 Regulations governing hearings may be viewed on the DCMS website. If the licensing authority decides that representations are relevant, it must hold a hearing to consider them. The need for a hearing can only be dispensed with by the agreement of the licensing authority, the applicant and all of the parties who made relevant representations. In cases where only 'positive' representations are received, without qualifications, the licensing authority should consider whether a hearing is necessary. To this end it may wish to notify the interested parties concerned and give them the opportunity to withdraw their representations. This would need to be done in sufficient time before the hearing to ensure that parties were not put to unnecessary inconvenience.

- 9.20 Responsible authorities should try to conclude any discussions with the applicant in good time before the hearing. If the application is amended at the last moment, the licensing committee should consider giving interested parties time to address the revised application before the hearing commences.
- 9.21 The Regulations require that representations must be withdrawn 24 hours before the first day of any hearing. If they are withdrawn after this time, the hearing must proceed. However, where discussions between an applicant and those making representations are taking place and it is likely that all parties are on the point of reaching agreement, the licensing authority may wish to use the power given within the hearings regulations to extend time limits, if it considers this to be in the public interest.
- 9.22 Applicants should be encouraged to contact responsible authorities before formulating their applications so that the mediation process may begin before the statutory time limits come into effect after submission of an application. The hearing process must meet the requirements of Regulations made by the Secretary of State. Where matters arise which are not covered by the Regulations, licensing authorities may make arrangements as they see fit as long as they are lawful.
- 9.23 There is no requirement in the Act for responsible authorities that have made representations to attend, but it is generally good practice and assists committees to reach more informed decisions. Where several responsible authorities within a local authority have made representations on an application, a single local authority officer may represent them at the hearing if the responsible

- authorities and the licensing authority agree. However, an officer of the licensing authority may not perform this role which would compromise the licensing authority's independence.
- 9.24 As a matter of practice, licensing authorities should seek to focus the hearing on the steps needed to promote the particular licensing objective which has given rise to the specific representation and avoid straying into undisputed areas. A responsible authority or interested party may choose to rely on their written representation. They may not add further representations to those disclosed to the applicant prior to the hearing, but they may expand on their existing representation.
- 9.25 In determining the application with a view to promoting the licensing objectives in the overall interests of the local community, the licensing authority must give appropriate weight to:
 - the steps that are necessary to promote the licensing objectives;
 - the representations (including supporting information) presented by all the parties;
 - this Guidance;
 - its own statement of licensing policy.
- 9.26 The licensing authority should give its decision at once, unless the Act itself states otherwise and provide reasons to support it. This will be important if there is an appeal by any of the parties. Notification of a decision must be accompanied by information on the right of the party to appeal. After considering all the relevant issues, the licensing authority may grant the application subject to such conditions that are consistent with the

operating schedule. Any conditions imposed must be necessary for the promotion of the licensing objectives; there is no power for the licensing authority to attach a condition which is merely aspirational. For example, conditions may not be attached which relate solely to the health of customers rather than their direct physical safety.

- 9.27 Alternatively, the licensing authority may refuse the application on the grounds that this is necessary for the promotion of the licensing objectives. It may also refuse to specify a designated premises supervisor and/or only allow certain requested licensable activities. In the interests of transparency, the licensing authority should publish hearings procedures in full on its website to ensure that interested parties and others have the most current information.
- 9.28 In the context of variations, which may involve structural alteration to or change of use of the building, the decision of the licensing authority will not exempt an applicant from the need to apply for building control or planning consent where appropriate.
