4. **LICENSING ACT 2003 - APPLICATION FOR A NEW PREMISES LICENCE – BARUBA, 4 CAMBRIDGE PLACE, EAST STREET, FARNHAM, SURREY, GU9 7RX**

5. LICENSING ACT 2003 - APPLICATION FOR A NEW PREMISES LICENCE – HASLEMERE BURGER AND KEBAB VAN, LION LANE, HASLEMERE, SURREY
