## **Summary and Purpose**

1. The purpose of the report is to enable the Sub-Committee to consider an application from Shottermill Club Ltd, for a new premises licence for Shottermill Club, 2 Liphook Road, Haslemere, GU27 1NL where 3 valid representations have been received.

#### Background

- 2. An application has been received for a new premises licence from Shottermill Club Ltd, attached at <u>Annexe 1</u>, who currently hold a Club Premises Certificate, attached at <u>Annexe 2</u> which they intend to surrender if the Premises Licence is granted, letter of intention at <u>Annexe 3</u>.
- 3. Shottermill Club is a purpose-built social club situated at 2 Liphook Road with a front entrance onto Weyhill. The building comprises of an entrance hall with corridor leading to toilets, a function room with a bar and separate office are located to the left of the corridor, with the main club bar and separate snooker and pool rooms to the right. A plan of the premises is attached at <u>Annexe 4.</u>
- 4. The applicant proposes that the premises licence will allow the sale of alcohol for consumption both on and off the premises and for regulated entertainment indoors only, some of which on a very occasional basis may be of an adult nature.

#### **Activities Sought under this Licence Application**

- 5. The applicant seeks to license the premises as shown below. An extract of the relevant pages from the application form is attached at <u>Annexe 1</u>. Also attached at <u>Annexe 5</u> is a plan showing the area of the premises and surrounding properties.

## **Licensing Objectives**

- Grant the application subject to such conditions as are consistent with the operating schedule modified to such extent as the Sub-Committee considers appropriate for the promotion of the licensing objectives, and any mandatory conditions;
- Exclude from the scope of the licence any of the licensable activities to which the application relates;
- Refuse to specify a person as the premises supervisor;
- Reject the application.
