# 4. Air Quality Steering Group

Joint steering group with Surrey County Council set up in 2017, with the aim of working together to improve the air quality in the Borough of Waverley, through behavioural, strategic and infrastructure change to ensure that the level of pollutants (nitrogen dioxide and particulates (PM10 and 2.5) are in line with national air quality objectives and that this work supports and the principles of sustainable development.

The approach of having a joint steering group is recommended by DEFRA (Local AQ Management Policy Guidance (PG16), April 2016) recognising that whilst district councils have responsibility for monitoring and reporting on air quality, many of the actions that will directly impact on improving air quality fall outside the responsibility of district councils – notably traffic/highways, and public health.

## 5. Waverley Champions

The role involves raising the profile and needs of the Armed Forces community (serving personnel, both regular and reserve, their families and veterans), within the Council and the Borough. Close liaison with the Council's Armed Forces Covenant Officer, with particular reference to the Council's obligations undertaken through the Armed Forces Covenant and the Community Covenant, will be essential.
