

Notice of General Exception Forthcoming Key Decision

Published in Accordance with Regulation 10 of The Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 ("the Regulations")

Regulation 9 of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 requires 28 clear days' notice to be published of the Council's intention to make key decisions. Regulation 10 (1) allows, that if it is impracticable for the Council to give the required 28 days' notice, the decision may still be made if the Chairman of the Overview & Scrutiny Committee has been given notice in writing of the matter about which the decision is to be made, a copy of the notice is made available for inspection by the public and is published on the Council's website, and at least 5 clear days have elapsed following the day on which the notice is made available for inspection by the public.

Notice is hereby given under Regulation 10 (3) of the intention to make the key decision set out below

Recommendations to Decision maker:

- 1. Award a contract for the supply of Electricity to the Council via the LASER consortium, for a two-year contract with the option to extend for one further year, worth up to £1,185,000 in total. This will be to the top ranked supplier on the Electricity framework – Npower.
- 2. Award a contract for the supply of Gas to the Council via the LASER consortium, for a two-year contract with the option to extend for one further year, worth up to £1,167,000 in total. This will be to the top ranked supplier on the Gas framework – Total Energies.
- 3. To delegate to the Strategic Director of Place, in consultation with the Borough Solicitor, to enter into contractual arrangements on behalf of the Council to implement these decisions
