4. <u>APPLICATION FOR PLANNING PERMISSION - WA/2015/2163 - GARDEN STYLE NURSERY, WRECCLESHAM HILL, WRECCLESHAM GU10 4JX</u> (Pages 1 - 100)

Proposal

Erection of 65 new dwellings, including 26 affordable, following demolition of existing buildings with associated access, car and secure cycle parking, landscaping and servicing at Garden Style Nursery, Wrecclesham Hill, Wrecclesham GU10 4JX (as amended by plans received 25/01/2016, 03/03/2016, 16/03/2016 and 23/03/2016 and as amplified by tree protection plan dated 01/09/2015 and arboricultural report dated 03/09/2015, additional geotechnical and geo-environmental report recieved 10/03/2016, noise and air quality letter dated 08/03/2016, highway improvements detail received dated 09/03/2016, accoustic fence technical information received 22/12/2016, marketing appraisal report dated 10/12/2015 and further supporting information received 25/01/2016, 26/01/2016, 11/03/2016)

Recommendations

Recommendation A:

That, subject to the completion of appropriate legal agreements by 07/07/2016 to secure 40% Affordable housing, S278 (off site) highway works, an Open Space, Play and Woodland/Ecological Management Plan, planning infrastructure contributions relating to waste and recycling, secondary education, community facilities, playing pitches, cycle and footpath improvements, SANG contributions, and subject to conditions 1 to 42 and informatives 1 to 19 as set out on pages 79 to 99 of the Report, permission be GRANTED

That, if the requirements of Recommendation A are not met, permission be REFUSED
