5. <u>A1 - APPLICATION FOR PLANNING PERMISSION - WA/2016/0101 - WOODSIDE PARK, CATTESHALL LANE, GODALMING</u> (Pages 5 - 68)

Proposal

Outline application for the erection of 107 dwellings, including 27 affordable together with the erection of a building of 930 sq. m. to provide a community use (Class D1) at ground floor level with office use (Class B1) above; together with associated amenity/play space, landscaping and parking following demolition of existing buildings. Access only to be determined at outline. As amended by plans and additional information received on 10/02/2016 and 18/03/2016

Recommendation

RECOMMENDATION A

That subject to consideration of the views of Surrey Wildlife Trust, the completion of a S106 legal agreement to secure 25% affordable housing, infrastructure contributions towards off site highway improvements, primary education, play spaces and open space, provision of and public access to rear open space, management and maintenance of on-site SuDS and public open and play space within 3 months of the date of resolution to grant permission and conditions, permission be GRANTED.

RECOMMENDATION B

That, if requirements on Recommendation A are not met, permission be REFUSED.
