Activities sought under this licence application

- 3. In brief, the applicant seeks to increase the terminal hour for all licensable activity on Thursday's till 0100 and Fridays and Saturdays until 0200. To also increase the terminal hour for opening, allowing the premises to close at 0130 hours on Thursdays and 0230 hours on Fridays and Saturdays. To remove and amend the non standard timings and conditions on the licence. Proposed changes to the licensable activity & opening hours are set out below.

- 6. Attached at Annexe 4 is a plan showing the area of the premises and surrounding properties

Representations received

7. Within the consultation period, eight valid 'relevant representations' were received. A representation is 'relevant' if it relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives.

Responsible Authorities

8. There have been no representations received from any of the Responsible Authorities.

Other Persons

9. There has been eight (8) relevant representation from "other persons". Copies of the representations are attached at <u>Annexe 5</u>

What the Sub-Committee may do

The Sub-Committee

- 10. Licensing authorities are required to carry out licensing functions under the Licensing Act 2003 with a view to promoting the licensing objectives of:
 - i. public safety
 - ii. the prevention of crime and disorder
 - iii. the protection of children from harm, and
- iv. the prevention of public nuisance.
- 11. In addition, when carrying out its licensing functions, the licensing authority must have regard to its own statement of licensing policy and the guidance issued under Section 182 of the Licensing Act 2003, available at:

https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment_data/file/705588/Revised_guidance_issued_under_section_182_of_the_Licensing_Act_2003_April_2018_.pdf

The Guidance will be available for reference purposes at the meeting.* Particular attention is drawn to:

Conditions – paragraphs 1.16-1.17 and 10.1 to 10.66

- The Licensing Objectives paragraphs 2.1–2.32
- Hearings paragraphs 9.31 to 9.44
- Regulated Entertainment 16.1 -16.9
- 12. The Sub-Committee must consider the application on its individual merits and take into account all relevant matters then determine the application by taking the steps it considers appropriate and necessary / proportionate to promote the licensing objectives.
- 13. When considering applications to vary an existing certificate, only the variation is subject to determination. No changes can be made to the certificate unless they are subject to the variation application.
- 14. Members are advised that when considering applications to vary an existing premises certificate, the following options are available to them by virtue of Part 3 Section 35(3) and (4) Licensing Act 2003. This provides that the Sub-Committee, having regard to the relevant representations made, must take such steps as it considers appropriate for the promotion of the licensing objectives. The steps are to:
 - a. modify the conditions of the certificate (conditions are deemed to be modified if they are altered, omitted or a new condition added); or
 - b. reject the whole or part of the application.

If neither of these steps are taken, the application must be granted.

Financial implications

15. There are no financial implications arising from this report.

Equalities and Human Rights

16. Under the Human Rights Act 1998, the Sub-Committee needs to consider the balance between the rights of the licensee and those making representations when making their decision. The Sub-Committee has a duty under section 17 of the Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the Waverley area.

Legal implications

- 17. The Licensing Act 2003 sets out how applications for Premises Licenses should be dealt with where valid representations have been submitted.
- 18. Where a decision is made that is contrary to or a departure from the statement of licensing policy and the guidance, the decision should clearly state on what basis a decision was made to depart from the policy or guidance.
- 19. An appeal against the determination of this application may be made to the Magistrates Court within 21 days of all parties being notified of the local authority's decision. The applicant or any party making representation may make an appeal.

Annexe 1 – Mandatory Conditions

Door Supervisors

Only individuals licensed by the Security Industry Authority may be used at the premises to guard against:

- a. unauthorised access or occupation (e.g. through door supervision), or
- b. outbreaks of disorder,
- c. damage.

Films

The admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendations made

- a. By the British Board of Film Classification (BBFC) where the film has been classified by that Board, or
- b. By the Licensing Authority where no classification certificate has been granted by the BBFC, or, where the licensing authority has notified the licence holder that section 20 (3) of the Licensing Act 2003 applies to the film.

Alcohol

No supply of alcohol may be made under the premises licence:

- At a time when there is no designated premises supervisor in respect of the premises licence.
- At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

- 1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.
- 4. The responsible person must ensure that—
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."
- **5**. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- **6.** For the purposes of the condition set out in paragraph 5—
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) "permitted price" is the price found by applying the formula—

$$P = D + (D \times V)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 7. Where the permitted price given by Paragraph (b) of paragraph 6 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 8. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 6 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

This application seeks to extend the trading hours at the premises by one additional hour on Thursday to Saturdays, amend non-standard timings for notable days as detailed in the application and update the conditions on the premises licence in accordance with detailed pre consultation which has taken place with the responsible authorities.

We have considered the impact of the proposed variation and have carefully considered the steps to be taken to ensure that the application and proposed operation will continue to promote the licensing objectives.

In particular we have undertaken consultation with the Police Licensing Officer and Environmental Health Officer prior to issuing the application and their comments have been taken into account in respect of the new set of proposed conditions.

The purpose for seeking the extension of one additional hour the terminal hour for licensable activities and opening hours on Thursdays, Fridays and Saturdays is to allow customers to stay in a well-managed, controlled and supervised premises for longer on these days, if they wish, and the applicant believes that the later hours will allow a longer wind down period and a more gradual dispersal of customers from the premises, which can be managed and contained, reducing impact on the area and licensing objectives by a mass dispersal at any one time.

A thorough set of conditions is offered as part of the application, including door staff and ID Scan, to ensure that the premises licence is suitable for the style of operation in the event that later hours are granted.

Stonegate are a well experienced licensed operator and have in place an extensive licensing manual containing policies and procedures across the whole estate, which are adapted at site level to ensure the premises operates to a high standard and promotes the Licensing Objectives. These include policies regarding social responsibility, training, underage sales and challenge policies, incident logs, queuing policy, drugs and dispersal policy, and noise management and the management of outside areas policies as well as procedures to prevent crime and disorder and public nuisance. These robust policies and procedures that already in place will continue to operate if the extended hours are granted.

Considering the above, we believe that the variation will not undermine the Licensing Objectives. The Applicant believes that the existing measures within the operating schedule, alongside the existing robust policies in place, the new proposed conditions and experience of the applicant, will ensure the premises continue to promote the Licensing Objectives if the application is granted.

b) The prevention of crime and disorder

- 5. A minimum of 2 notices stating that CCTV is in operation shall be displayed throughout the premises where members and guests have access.



 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:

- a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
- a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
- a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
- a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
- a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider:
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
- 4. Where taking place in a building or other structure please tick as appropriate. Indoors may include a tent.

Farnham Town Council objects to the variation of the premise licence under objectives b), c), d). Extending the licensing hours will increase anti-social behavior in area which is having a large amount of residential accommodation in the Brightwells and Woolmead developments to the north and east of the premise. The stated hours must be subject to a late-night levy to cover the cost of addition policing to mitigate crime and disorder and public nuisance and assist with public safety.

CONCERN OVER PROPOSED VARIATION TO EXTEND HOURS

I write to express my considerable concern over the likely impact if the application by Stonegate Pub Company to vary its licence to extend the hours that it is able to sell alcohol at its premises at Slug and Lettuce, 9-11 East Street, Farnham to 0100 hours on Thursdays/Fridays and 0200 on Fridays/Saturdays and Saturdays/Sundays with a further 30 minutes allowed before the doors are finally closed (0130 Fridays and 0230 Saturdays and Sundays) is granted.

Whilst this particular premise is located in Farnham Moor Park ward which is not the ward that I represent it is very close to the ward that I do represent in Farnham Castle and if granted it would inevitably affect a number of residents and businesses in Farnham Castle ward.

My specific concerns are as follows: -

- As far as I am aware no other premise in Farnham has a licence to sell alcohol as late as proposed by this variation. If granted it seems inevitable that other premises selling alcohol in Farnham will then apply for similar a variation to extend hours at their locations in order to maintain competitive advantage which would be unfair on the significant number of residents who live in Farnham Town Centre from whom there is already a number of complaints regarding noisy behaviour particularly at weekends through existing licences which allow extended hours up to 0100 on Saturdays and Sundays to sell alcohol;
- It should be remembered that the Slug and Lettuce is located close to the current redevelopment of Brightwells and Woolmead both of which have a high number of proposed residential dwellings. In a very short period of

- time this will, therefore, become a relatively high density residential area; and
- Any extension of hours during which alcohol may be sold is likely to increase the level of anti-social behaviour. Over the past 12 months it appears that the level of anti-social behaviour has been increasing resulting in the Police having to resort on occasions to dispersal orders. Any extension of hours during which alcohol could be sold will inevitably result in an increased likelihood of anti-social behaviour occurring.

I do not, therefore, believe that this application to vary by extension of hours meets the licensing objectives by which this application should be reviewed. I would hope that the above comments will be given very careful consideration when this variation to a licence for the Slug & Lettuce is being determined.
