Cllr Mark Merryweather presented the Annual Financial Report and Accounts for the year ended 31 March 2020:

The purpose of the meeting was for the council, acting as sole Trustee for the Shottermill Recreation Ground Trust, to approve the Annual Financial Report and Accounts for the year ended 31 March 2020. The Trust owned the Haslemere Leisure Centre which was operated through Waverley's management contract with Places Leisure.

Cllr John Robini referred to planning application TC/2020/0009 for the erection of a telecommunications mast at the Haslemre Leisure Centre, and queried whether the Council as Trustee would be required to give consent to the location of the mast, independently of the council's decision as the Local Planning Authority. Mr Bainbridge, the Borough Solicitor, advised that he would follow-up with Cllr Robini after the meeting on the potential impact of the planning application.
