3.1 LICENSING ACT 2003 - APPLICATION APPLICATION TO VARY A PREMISES LICENCE FOR THE LEATHERN BOTTLE, 77 MEADROW, FARNCOMBE, GODALMING, SURREY GU7 3JG (*Pages 5 - 32*)

The purpose of the report is to enable the Sub-Committee to consider an application which has been received under the Licensing Act 2003 from the premises licence holder - Mr Peter Hirons ('the Applicant'), to vary the Designated Premises Supervisor (DPS) naming himself as the proposed DPS for The Leathern Bottle, 77 Meadrow, Farncombe, Godalming, GU7 3JG. The application has been brought before the Sub-committee as an objection notice to the proposed variation of this licence has been received from Surrey Police.

It is a mandatory condition under the Licensing Act 2003 that, where the supply of alcohol is one of the licensable activities, there must be a Designated Premises Supervisor (DPS). Guidance states that the Designated Premises Supervisor should normally be the individual who is in day-to-day control of the premises. This is to provide a single point of accountability within the premises should any problems arise.

Recommendation

It is recommended that the Sub-Committee considers the application and evidence of all parties involved at the hearing and then determine the application with a view to promoting the licensing objectives.

• Members must determine the application in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.

The Sub-Committee should take such steps (as described at paragraph 6.9 below) as it considers appropriate for the promotion of the licensing objectives.

The Sub-Committee is recommended to give appropriate weight to:

(a) The steps that are appropriate to promote the licensing objectives;

(b) The representations (including supporting information) presented by all parties;

(c) Waverley's Statement of Licensing Policy.

(d) The Guidance issued to local authorities under Section 182 of the Licensing Act 2003 (as amended April 2018).

3.2 LICENSING ACT 2003 - APPLICATION FOR A REVIEW OF PREMISES LICENCE [THE LEATHERN BOTTLE, 77 MEADROW, FARNCOMBE, GODALMING, GU7 3JG (*Pages 33 - 116*)

The purpose of the report is to enable the Sub-Committee to determine a request from Surrey Police for a review of the Premises Licence for the Leathern Bottle, 77 Meadrow, Farncombe, Godalming, GU7 3JG under section 51 of the Licensing Act 2003. Twenty Eight relevant representations have been received from 'other persons', all in support of the premises.

Recommendation

It is recommended that the Sub-Committee determine the application.

4. <u>LICENSING ACT 2003 - APPLICATION TO VARY A PREMISES LICENCE-</u> CARLO ITALIAN BISTRO, 3 HAMPTON TERRACE, BEACON ROAD, BEACON HILL, SURREY GU26 6NR (Pages 117 - 146)

Summary and Purpose

The purpose of the report is to enable the Sub-Committee to consider an application

for a variation to the Premises Licence of Carlo Italian bistro, 3 Hampton Terrace, Beacon Road, Beacon Hill, Surrey GU26 6NR section 34 of the Licensing Act 2003, made by Manuel Rocha as agent on behalf of Papagni Ltd, the current Premises Licence Holder. A representation has been received by the Licensing Authority and therefore the application must be determined by the Sub-Committee.

Recommendation

• It is recommended that the Sub-Committee considers the application

and evidence of all parties involved at the hearing and then determines the application.

• Members must determine the application in accordance with the Licensing Act 2003 (Hearings) Regulations 2005.

• The Sub-Committee should take such steps (as described at paragraph 13.10 below) as it considers appropriate for the promotion of the licensing objectives.

Once determined, the licensing authority must provide notification of the decision including its reasons to the applicant, any person who has made relevant representations and the Chief Officer of Police for the area in which the premises is situated.
