4. **LICENSING ACT 2003 - APPLICATION FOR A NEW HACKNEY CARRIAGE/PRIVATE HIRE DRIVERS LICENCE** (Pages 5 - 22)

The purpose of this report is to enable the Sub-Committee to consider a new application for a hackney carriage/private hire driver's licence. The applicant has disclosed on his application form and also disclosed on his enhanced Criminal Records (DBS) check, is a conviction, 'Using threatening, abusive, insulting words or behaviour W/I [with intent] to cause fear or provocation of

violence', on 9 May 2015 for which he received a community order/costs/unpaid work requirement and victim surcharge on 19 February 2016.

Recommendation

5. LICENCING ACT 2003 - REVIEW OF A HACKNEY CARRIAGE/PRIVATE HIRE DRIVERS LICENCE AND THEIR SUITABILITY TO HOLD SUCH A LICENCE FOLLOWING A NUMBER OF DRIVING CONVICTIONS. (Pages 23 - 48)

The purpose of this report is to enable the Sub-Committee to consider a existing licensed hackney carriage/private hire driver and his suitability to hold such a licence following a number of driving convictions, acquiring a current total of 9 penalty points on his DVLA driving licence. The driver also failed to notify the Council of his latest motoring conviction, speeding (SP30) within 48 hours, in accordance with Waverley's Hackney Carriage/Private Hire policy.
