4. <u>LICENSING ACT 2003 - APPLICATION FOR A NEW HACKNEY</u> <u>CARRIAGE/PRIVATE HIRE DRIVERS LICENCE</u> (Pages 5 - 44)

The purpose of this report is to enable the Sub-Committee to consider a new application for a hackney carriage/private hire driver's licence. The applicant has disclosed on his application form that he had previously held private hire drivers licence's with Guildford Borough Council and with Woking Borough Council, both of which had been revoked. The driver also disclosed that

Transport for London (TFL) had refused him a licence. Although the drivers criminal record check (enhanced DBS) shows no offences recorded, he has disclosed on his application form that he received a Police Caution on 01/01/2017 for 'Damage to Property Value under £5000'.

Recommendation

It is recommended that the Sub-Committee give consideration to the application and his previous driving record
