

Regulation 123 List

- 1.1 The 'Regulation 123 List' sets out those types of infrastructure or specific infrastructure projects that the Council may fund (in whole or part), through the Community Infrastructure Levy (CIL). The inclusion of a project or type of infrastructure on the list does not signify a commitment from the Council to fund the listed project or type of infrastructure. Nor does the order of the list imply any preference or priority. The process of governance for CIL expenditure will be carried out separately whilst having regard to the Regulation 123 list.
- 1.2 The table below sets out the Council's Regulation 123 list. The list will be reviewed and updated when needed, including proportionate consultation with interested parties.
- 1.3 The Council will continue to secure the following mitigation and policy requirements through planning obligations (S106):
 - Site-specific infrastructure requirements, including highway works, provision of open space, and other infrastructure and facilities necessary for the development of a specific site (that would not result in pooling of more than five such planning obligations)
 - Strategic Access Management and Monitoring (SAMM) and maintenance of existing SANG for the Thames Basin Heaths Special Protection Area
 - Measures to secure mitigation/avoidance for the Wealden Heaths SPA
 - Affordable housing.
- 1.4 These will be subject to the statutory tests set out in CIL Regulation 122. A planning obligation can only be taken into account when determining a planning application for development, or any part of a development, if the obligation meets all of the following tests, whereby it is:
 - a) necessary to make the development acceptable in planning terms;
 - b) directly related to the development; and
 - c) fairly and reasonably related in scale and kind to the development.
