We strongly object to the proposed hours of licensing, which are excessive and will have a material adverse effect upon a large number of residents and their amenity. Particularly if they live in very close proximity to the Castle.

We note that the current licensing hours in respect of the Centre for International Briefing (Compass Group Farnham Castle) although late, are licensed indoors. The new application is asking for outdoor, DJ/dance, musical entertainment, supply of hot food and alcohol until 2pm potentially everyday of the week. Our greatest concern is the level of noise and disruption residents will suffer every night of the week, particularly in the Summer.

Castle Street has a large number of residential occupants and this venue is located in the heart of a conservation area. Residents are very sensitive to noise, particularly at night when there is limited background noise. You might want to enquire with your colleagues in environmental health, who have received many resident objections in the past.

I would be grateful if you could give careful consideration to residents concerns.
