Statement of Truth

My name is Mircea Adrian Daniel TUDOR (but people call me 'Mick').

I am the director of MT Telecoms Ltd, Company Number 11337851 incorporated on 1 May 2018. Our Regd Office is at 27 Old Gloucester Street, LONDON WC1N 3AX and we trade from 17 Lakeland Drive, Frimley, CAMBERLEY GU16 8LD.

By profession I am a CCTV Engineer and I have over ten years' experience in this business.

On Tuesday 7th June 2022 I went to the Leathern Bottle, 77 Meadow, Farncombe, GODALMING, Surrey GU7 3JG, as I had been engaged to assess and/or address the functionality and performance of the CCTV system installed at these premises by Mr Peter HIRONS.

There I inspected the system and found it to be a four-camera system, each of 5 mega pixel strength with wide view lenses, sited to provide coverage of:

1. Front door (outside providing coverage as far as the carpark)
2. Back garden
3. Side Gate
4. Bar (showing the interior of the premises).

These cameras provide colourised images in ambient light and also night vision. They were all checked and found to be in perfect working order.

I then examined the hard drive storage capacity and found it to be 2tb. However, on instruction I added a further 2tb of hard drive to provide a memory capacity of about 50 days retention. Again, the system was examined and found to be in perfect working order.

I have further been engaged by Mr HIRONS to provide training sheets that enable any staff (authorised but unsupervised) to access the system when

required, isolate pieces of footage and then download a copy of that footage onto flashdrive(s) so that these images can be provided to the Police when required and in a format that they can use.

In my opinion, this CCTV system is now fit for purpose.
