Supplementary Planning Document: Climate Change and Sustainability September 2022

REGULATION 12 - TOWN AND COUNTRY PLANNING (LOCAL PLANNING) (ENGLAND) REGULATIONS 2012

This consultation statement has been prepared in accordance with Regulation 12(a) of the Town and Country Planning (Local Planning) (England) Regulations 2012, which states that before a local planning authority adopts a supplementary planning document it must prepare a statement setting out:

- i. The persons the local planning authority consulted when preparing the supplementary planning document;
- ii. a summary of the main issues raised by those persons; and
- iii. how those issues have been addressed in the supplementary planning document.

This statement sets out who was consulted in the preparation of the draft Supplementary Planning Document: Climate Change and Sustainability, how they were consulted, what issues were raised and how those issues influenced the preparation of the document.

Supplementary Planning Documents (SPDs) seek to expand on existing planning policy, to provide detail and depth that may not be possible in a Local Plan. The purpose of the Climate Change and Sustainability SPD is to set out guidance on the implementation of the key Climate Change and Sustainability policies in the adopted Waverley Local Plan Part 1: Strategic Policies and Sites (LPP1) which was adopted by the Council on 20 February 2018. The SPD is also part of the Council's response to the climate emergency.

The SPD covers topics related to minimising energy use in new developments, sustainable site layout, landscaping, layout, and orientation of buildings, climate change resilience and adaptation, use of sustainable resources and materials and sustainable management of waste, water efficiency, and design to encourage use of sustainable forms of transport. The SPD does not create new policy, it provides a further level of detail to guide development proposals.

Once adopted the SPD will be a material consideration in the determination of planning applications, alongside the Local Plan and other planning policies.

Consultation: Stage One

The contents of the draft Climate Change and Sustainability SPD have been subject to discussion and meetings between the consultants, officers, Members and external stakeholders. Detailed comments were received on the scope and content of the SPD.

Consultations were held as follows:

- Online meetings with Waverley Borough Council (WBC) Planning Policy Officers in late October and early November 2021 to discuss the proposed scope of the SPD.
- Online meeting with WBC Development Management Officers on 17th November 2021.
- Online meetings with relevant WBC Councillors on 1st December 2021 and 19th January 2022.
- Online consultation with external stakeholders on 15th December 2021. Invites were sent to Surrey County Council, Surrey Wildlife Trust, Surrey Nature Partnership, the

Carbon Trust, Extinction Rebellion, Farnham BAP, Borne Conservation Group, Waverley Friends of the Earth and Surrey Climate Commission.

Appendix 1 provides a summary of the response to comments raised.

Comments were also received on the draft SPD from the WBC Overview and Scrutiny Committee on 21st March 2022.

Consultation Process

The Draft Climate Change and Sustainability SPD was consulted on between 28th June and 29th July 2022 in accordance with the Council's Statement of Community Involvement. The Council published the Draft SPD and accompanying document on its website and planning policy consultation portal and placed hard copies in the Council's offices and local libraries. All members of the Council's local plan database were notified of the consultation by email or letter. The database includes statutory consultees, town and parish councils, residents associations/groups, local businesses, developers and landowners and Waverley residents. A public notice was also placed in the Surrey Advertiser and Farnham and Haslemere Heralds setting out the details of the consultation and how representations could be made.

A consultation briefing session for the town and parish councils was held via Zoom on 27th June 2022.
