1. The Prevention of Public Nuisance

According to the new Waverley Borough Council Licensing Policy 2023 (Hereby known as WBCLP2023), point 8.5.7 (Measures to reduce the impact that the use of gardens or other open-air areas will have on local residents and businesses) is not being addressed adequately.)

There is a public nuisance in the GNC carpark made up of members' noise nuisance, noxious smells: loud and disruptive behaviour on a daily basis anytime during opening hours until 21:00: foul language and coarse conversations, all private to the members and not for public consumption, but yet projected into the homes of the surrounding neighbours without any thought or concern for their distress or their own private lives. These residencies all predate the GNC's existence. The GNC has also allowed several breaches of license to go unchallenged, forcing residents to make complaints, gather evidence, and engage a Police Action in September 2022, resulting in a letter of sanction October 2022. When challenged in 2022 after continued license breaches by GNC that disturbed residents, there was an incident where threats of violence were made directly from the carpark to residents that required a Police response September 3rd 2022. Because the threats showed knowledge of the complaints already made to WBC prior to the disturbance at, this shows they were part of the GNC, either committee or members.

WBCLP2023 point 8.5.10. (Measures to minimise the impact of refuse storage or disposal (including noise associated with bottle delivery and disposal), or additional litter (including fly posters and unauthorised placards) in the vicinity of the premises) is not being adequately addressed.)

Glass bottle waste is still disposed singly into the bins, with greater frequency as trade has expanded, and the bins are still currently collected at 05:30-05:45 every Wednesday morning, which is grossly intrusive in volume and disturbance and as an unwanted alarm call at an unreasonable hour. Every week.

This, despite many previous complaints to WBC to enforce compliance with license and/or contractor.

WBCLP2023 6.17 ('The absence of a special policy does not prevent any responsible authority or any 'other person' making representations on a new application for the grant, or variation, of a premises licence or club premises certificate on the grounds that the premises will give rise to a negative cumulative impact on one or more of the four licensing objectives.')

We believe that there has been a negative cumulative impact on the residents as the club has extended its licensable operating hours, extended the geography, and seemingly merged off and on sales areas. We are totally confused as to the regime parameters, and require clarification in committee.

WBCLP2023 6.21(Planning Controls)

The residents have not been able to bring forward this complaint to sub-committee previously, as enquiries to WBC have been rebuffed with the blanket use of the extraordinary Covid licensing regime that is still in place. However, this has been completely undermined by WBC Environmental Health confirming in writing that the Covid regulations were never applicable to GNC and this site.

If that is so, then where is the planning application to create a permanent beer garden?

Where is the consent from The Environment Agency for a change in the geographic flood profile?

Where are the planning controls mentioned in the Licensing Policy?

The main area of concern here is that the carpark has been developed into an outdoor pub garden, without any formal planning content being sought, or permission granted by responsible authorities such as The Environment Agency: the flood risk profile has been permanently adjusted without their knowledge or prior consent.

When first constructed, the Club Secretary Pete Ross confirmed it was a temporary measure to allow functionality during the Covid-19 Pandemic,

and this was backed up in writing by WBC in correspondence in July 2020. The neighbours showed forbearance.

Secondly the previous license application by GNC of Nov 2021 was to support the business during Covid by allowing 'Off sales, amend restrictions around protection of children.'

Not to create a new area for off-licence drinking onsite. This was not specified in the application summary: the sub-committee meeting was not attended by residents as we were in near lockdown, unable yet to receive vaccinations, so genuinely fearful of attending committees in person. Also the neighbourhood wanted to be supportive of a local business at this time. So all the requests of GNC appear to have been approved without objection or even discussion with affected parties.

In August 2022, confirmed in writing that the situation was never subject to the relaxation of the licensing regime and pavement licensing, as the operation falls wholly on private land.

Surely as such, planning regulations should apply, building regulations for their permanent structures, and an opportunity for residents to voice reasonable grounds for objection. Approval for this has never been sought.

We want to take this discrepancy to the license sub-committee to understand their part in this and to raise objections, with the aim of rolling back the license to the status in 2019/202, where T.E.N. permits could allow GNC to operate in this location on a case by case basis, in agreement with the local residents, not permanently.

Protection of Children

WBCLP2023 Point 9.1(Protection of children from harm includes the protection of children from moral, psychological and physical harm, and this would include the protection of children from too early an exposure to strong language and sexual expletives)

There is no mitigation by members in their choice of adult language and conversations when children are present. I have been an unwilling witness to this for 3 years since they have been adjacent to

Prevention of Crime and Disorder

As an immediate neighbour, we have witnessed multiple arguments, fights, and potentially criminal behaviour at GNC over the past 16 years. We do not have records of all of them, but we do have a video recorded on 5th April 2023, at 22:39 that witnessed the latest serious disturbance from within a neighbouring property with the doors and windows closed, such was the noise generated. It occurred either in the carpark, or in the footpath between GNC and Sweetapplehouse in the previous 'smoking area'. We can provide a copy to the committee or officers on request. We believe that the Police Authority Liaison Officer should become involved for their view on the siting and existence of the beer garden area.
