Notes:

1. Members of the Audit & Risk Committee must not be Executive members.
2. The Leader of the Council may not be a member of the Standards & General Purposes Committee, and the membership may include no more than one Executive member.
3. The Standards & General Purposes Committee will co-opt two Town/Parish councillors from within the Waverley Borough who are not also Waverley Borough Councillors and who will serve until the next Town and Parish elections. At least one Town/Parish co-optee must be present when matters relating to Town and Parish Councils or their members are being considered. Town/Parish co-optees may not participate in matters that do not relate to Town and Parish Councils or their members.
4. Members of the Executive may not be members of the Overview and Scrutiny Committees.

Substitutes (Procedure Rule 2.4.7)

For each political group represented on a committee, all members of that group not appointed to that committee, shall be designated as substitute members for the member or members of that group who have been appointed to that committee, subject to the exceptions listed below.

- No member of the Executive may be appointed as a substitute member in respect of an Overview and Scrutiny Committee.
- Substitutes on committees, subject to the political balance regulations may only be substituted for members of the same political group except where a substitute is necessary for the committee to operate effectively, and the political group does not have sufficient membership to appoint a substitute, or the substitute is not able to attend. In these circumstances, the Monitoring Officer may, having regard to the rules of political proportionality, and in consultation with the member who is unable to attend, invite any other member who has been designated as a substitute for that committee, to attend.
- No member may be appointed as a substitute member of the Planning Committee, Licensing & Regulatory Committee and Standards & General Purposes Committee who does not meet the requirements for training referred to in the terms of reference of any particular committee and set out in Part 3 of the Constitution.
- No member of the Executive may be substituted.
